National Bank for Agriculture and Rural Development (NABARD) was established in 1982 by Act of Parliament and is an apex level financial institution owned by the Government of India and Reserve Bank of India. NABARD intends to install Access Control System at its Regional office at NABARD Tower, Usmanpura, Ahmedabad and accordingly invite applications from parties satisfying the following criteria:

- i) Should have a proven track record in the supply, installation and commissioning of the Access Control System during last 7 years.
- ii) Should have installed such system in major public/private banks /Government organisations/PSUs.

- iii) Should have an annual turn over during each of the last 3 years at least Rs.21 lakh .
- iv) Should have completed atleast one work costing not less than Rs.5.6 lakh during the preceding 5 years
OR
Should have completed atleast 2 works costing each not less than Rs.3.5 lakh
OR
Should have completed atleast 3 works costing each not less than Rs.2.8 lakh

Following proof of compliance with the aforesaid criteria may be submitted along with applications :

- i) copy of relevant work orders and work completion certificate.
- ii) copy of the income tax returns for the preceding 3 years.ie.for the financial years 2008-09, 2009-10 and 2010-11.

Scope of Work

Installation of the Access Control System (ACS) at our Regional Office at NABARD Tower, Opp. Municipal Garden, Usmanpura, Ahmedabad-380013. The ACS will provide for controlled access to the Bank's premises using proximity card readers, Tripod Turnstile and related software. This system will also use Time Attendance software and will be linked with the printers and servers. The printers and servers will be placed in the place as decided by the Bank. The work will entail providing necessary hardware, software, signal and power cabling, providing PC and printer and all allied civil, electrical and carpentry work. The access will be controlled by providing Tripod Turnstiles at the entrance to the Lift lobby at the Ground Floor, near the main entrance.

Annual Maintenance Contract for five years after the defect liability period will also be provided by the Party.
