- ii) Should have installed such system in major public/private banks/Government organisations/PSUs.
- iii) Should have an annual turn over not less than Rs.7 lakh during the preceding 3 financial years.
- iv) Should have completed atleast one work costing not less than Rs.16 lakhs during the preceding 5 years.
- v) Should have completed atleast 3 works costing not less than Rs.8 lakhs during the preceding 5 years.

- i) copy of relevant work orders and work completion certificate.
- ii) copy of the income tax returns for the preceding 3 years.ie.for the financial years 2004-05,2005-06 and 2006-07.
