Rs. 14 lakhs (Rupees Fourteen lakhs only). The work is to be completed within 3 months (including monsoon months).

Only Civil Contractors with about 10 years experience with Rs. 50 lakhs yearly turnover and having completed a minimum of two works of similar nature individually costing at least Rs. 7 lakhs (Rupees Seven lakhs only) need apply in the prescribed Application form which is appended below. The last date for receipt of filled-in application form is by 5 p.m. on 27/04/2007. **Instructions to the Applicants for furnishing

1. Intending Applicants are required to submit their full bio-data giving details about their organisation, experience, technical personnel in their organisation, space capacity, competence and adequate evidence of their financial standing, etc. in the enclosed form which will be kept confidential.
2. While deciding upon the selection of contractors great emphasis will be given on the ability and competence of applicants to do good quality works within the specified time schedule and in close co-ordination with other agencies, besides the rate structure of the items. Also, emphasis will be given to the applicants who have executed majority of the similar works (seepage repair works to buildings) in and around Chennai and who have their working Office in Chennai.
3. Decision of the Bank in regard to selection of contractors for issue of tender forms will be final. The Bank is not bound to assign any reason therefor.
4. Each page of the application shall be signed. The application shall be signed by person/persons on behalf of the organisation having necessary authorisation/Power of Attorney to do so.
5. If the space in the proforma is insufficient for furnishing full details, such information may be supplemented on separate sheets of paper stating therein the part of the proforma and serial number. Separate sheets shall be used for each part.
6. Any letter or document accompanying the pre-qualification form shall be submitted in duplicate.
7. Applications containing false and/or inadequate information are liable for rejection.
8. While filling up the application with regard to the list of important projects completed or on hand, the applicants shall only include those works which individually cost not less than Rs. 7 lakhs.
