

NATIONAL BANK FOR AGRICULTURE AND RURAL DEVELOPMENT

1. The National Bank for Agriculture and Rural Development (NABARD) invites sealed tenders from reputed watch manufacturing companies for supply of 6000 sets of watches of standard size with NABARD Logo on its Dial and "NABARD's 25 years of service to the nation" engraved on the back of the watches in an attractive pack. One set should contain one gent's and one lady's watch. Consignments containing specific number of sets to be indicated by NABARD, will have to be delivered at its offices located at all State Head Quarters across the country. The estimated cost would be around Rs.95 lakhs (all inclusive).
2. The companies, which are registered and empanelled with the Government or Semi Government undertakings as suppliers and who have executed at least three similar orders in the past may apply in the prescribed form given in Part-I (Pre-qualification criteria for suppliers is given in the Annexure).
3. Interested parties are required to furnish details about their company and evidence of their financial standing as per the enclosed proforma given in Part-I.
4. **While deciding upon the selection of suppliers, emphasis will be given on the quality of the watches and their ability to supply the watches within the prescribed time schedule.**
5. The application form shall be signed only by a person on behalf of the company, authorised to do so.
6. Applications containing inadequate information are liable for rejection.
7. The prescribed proforma duly filled in should be submitted in duplicate in sealed cover addressed to Shri Lajja Ram, Chief General Manager, NABARD, General Administration Dept., Ground Floor, 'E' Wing, Plot No.C-24, 'G' Block, Bandra-Kurla Complex, Bandra (East), Mumbai - 400051, so as to reach him not later than 06 July 2007.
8. The Bank reserves the right to reject any or all applications without assigning any reason thereof.

ANNEXURE

Pre-qualification criteria for suppliers

I Pre-qualification criteria for intending companies :-

1. Companies have an annual turnover of more than Rs.50 Crores.
2. Companies should have executed at least 3 similar orders in the past.
3. Companies should have after sales service network across the country.
4. Companies should be able to give warranty for at least two years for the watches.
5. Companies should be able to arrange delivery of these watches at the State Head Quarters where NABARD has its offices.
6. Companies should be willing to replace the defective sets immediately without any additional cost.
7. Company will furnish a Bank Guarantee on Awarding the Contract/Order for an amount equivalent or more than the contract amount.
