You are requested to send your most competitive offer in a sealed cover in the enclosed form. The envelopes should be super scribed **Supplying and installation of Neon Sign board at NABARD TOWER, Usmanpura, Ahmedabad** and should be addressed by name to Shri B.S. Shekhawat, Chief General Manager, Gujarat Regional Office , National Bank for Agriculture and Rural Development, NABARD Tower, Near Municipal Garden, Usmanpura, Ahmedabad 380 013 and should reach our office **latest by 17:00 hours on 08 May 2008**.

The quotations will be opened at 03.00 pm on the next working day in presence of the representative of the contractors who chose to be present during that period / time. You may visit the site on any working day except on Saturday, Sunday and holiday between 8:30 hours and 12:30 hours to ascertain the nature and scope of work in consultation with Estate Department and PSO / Care taker at site. The contractors are requested to enclose an amount of Rs 2,400/- towards EMD in the form of DD or Pay order drawn on any schedule Bank in favour of NABARD. Quotations without EMD are liable for rejection. In addition to EMD an amount 5% of the total bill amount shall be deducted from contractors bill towards RMD and the total EMD+RMD collected shall be released after a defect liability period of six months from the date of virtual completion of work.

The following conditions may be noted.

- 1) The cost submitted will be final and include all taxes, duties, VAT, Fee to local Municipal authorities if any, levies, service charges, labour, transportation etc. No increase in cost will be considered under any circumstances.
- 2) The quantities mentioned in the quotation may either increase or decrease depending on site conditions and no additional rates are allowed for the increase/decrease in the quantities of work under any circumstances.
- 3) The validity period of quotations is two months from the date of opening of quotations.
- 4) All payments will be made by a/c payee cheque payable in Ahmedabad after satisfactory completion of the work.
- 5) Workmanship should be of high quality or no payments will be made.
- 6) The work area should be cleaned after the work is completed.
- 7) Damages occurred to existing material / works at the time of execution of proposed work shall be made good by the contractor to the satisfaction of Bank at his cost.
- 8) Payment will be made after inspection by our bank's official and certification of work quality by ACT/ PSO and our Engineer.
- 9) Bank reserves the right to accept/reject any or all quotations without assigning any reason.
- 10) It is binding on the contractor to arrange for an inspection by the authorities of Ahmedabad Municipal corporation if necessary. The Contractors will be governed by local labour laws/Acts in force.
- 11) Contractors are required to follow latest safety code at the time of work and Bank will not take any responsibility for the damages if any occurred at the time of execution of work.
- 12) All the items mentioned in the quotation may be carried out as per the latest specifications prescribed by local Municipal authorities /BIS/ ISI /ISO and also in consultation with local Municipal authorities.
- 13) The Contractors shall strictly follow the insurance contract conditions i.e. Contractors liability and insurance and also the latest safety code at the time of execution of work. The conditions will be furnished by NABARD to the eligible Contractor along with the work order
