Quotation for LCD projector, Motorised Screen and Visualiser

1. मोहरबंद निविदा **श्री सुखबीर सिंह, मुख्य महाप्रबंधक, राष्ट्रीय बैंक, लखनऊ** के नाम संबोधित होनी चाहिए।
2. निविदा के लिफाफे के ऊपर **LCD projector, Motorised Screen** की आपूर्ति हेतु निविदा" अवश्य लिखा होना चाहिए।
3. निविदा के साथ फर्म के TAN/PAN संख्या अवश्य उल्लिखित होनी चाहिए अन्यथा निरख निरस्त करने का अधिकार बैंक के पास सुरक्षित है।
४. राष्ट्रीय बैंक नियमानुसार आवश्यक वैधानिक टैक्स की जैसे आयकर, टर्नोवर टैक्स, कान्ट्रेक्ट टैक्स, ट्रेड टैक्स कटौती करने के लिए अधिकृत होगी।
५. किसी भी विवाद की स्थिति में राष्ट्रीय बैंक को अपने निर्णय का अधिकार सुरक्षित होगा।
६. किसी / सभी निविदाओं / अनुमानित लागतों, सामग्री की मात्रा को कम ज्यादा करना एवं बिना कोई कारण बताए अस्वीकृत करने का अधिकार बैंक के पास सुरक्षित है।

९. निविदाकर्ता निविदा/निरख जमा करने से पहले साईट देखकर तथा पूर्णत सन्तुष्ट हो लें

**Tender for Supply of LCD Projector and Motorised Screens at
National Bank for Agriculture and Rural Development
Lucknow**

Special terms and Condition

1. Sealed tenders are invited for the work of supply of LCD Projectors and Motorised Screens at NABARD Regional Office at 11, Vipin Khand, Gomti Nagar, Lucknow-226 010. The tenders shall be addressed by name to Shri Sukhbir Singh, Chief General Manager, NABARD, Lucknow so as to reach him not later than 3.00 PM on 14 Dec 2007. The tenders shall be opened on the same day at 3.30 PM in the presence of the tenderers who wish to be present.
2. NABARD reserves the right to accept or reject any or all the tenderers in full or in part, without assigning any reason thereof. The Bank also reserves the right to accept the tender of any firm. Tenderers are requested to quote unit rates and amounts separately. They are also advised to use the enclosed proforma only. No additions are required to be made by the tenderer on the enclosed proforma.
3. The tenderers shall pay as earnest money a sum of Rs. 6,000/- (Rupees Six thousand only) by demand draft in favour of NABARD, Lucknow drawn on a scheduled bank payable at Lucknow. The EMD of the successful tenderer shall be converted into Security deposit and kept for a period of one year till the expiry of the defects liability period.
4. The tenders shall be valid for a period of 90 days from the date of opening of the tender.
5. The rates quoted shall be inclusive of all taxes, duties, levies, transport, packing, forwarding, insurance etc. and shall be for the complete work duly installed and commissioned at site. The prices quoted shall remain firm for the entire period of contract and shall not be subjected to any variations in rate of foreign exchange rate or variations of any other taxes, levies, duties, etc. No import license will be furnished by Bank. The tenderer shall make his own arrangement for any statutory obligation like transit points, input required, if any, for safe delivery of material at site.
6. The entire work of supply, installation, testing and commissioning of the system shall be completed within a period of 3 weeks from the 10th day of issue of work order.
7. The equipment's supplied shall be new and guarantee/warantee against all types defects for a minimum period of one year from the date of virtual completion of work. Any defects of the system/ sub- assemblies found within the guarantee period shall be rectified/ replaced by the tenderer free of cost. During this period, servicing at bi-monthly interval or earlier, as prescribed by the manufacturer and as mutually agreed to, shall be



carried out free of cost. Tenderer shall also indicate the service facility they can offer at the place of installation and the telephone number and address of their service centre.

The tenderers shall also quote their charges separately for comprehensive maintenance service to be provided after the expiry of the one year guarantee period for consideration by the Bank. The rate for the service contract shall be applicable from the date of expiry of guarantee period.

During the AMC period tenderers have to keep the system in working condition at all time, including Batteries.

8. Test certificates shall be given by the supplier with the equipments.
9. Payment shall be made within 15 days on satisfactory supply, installation, testing and commissioning of the UPS and on production of bills.
10. Tenderer/ contractor under shall pay all taxes, duties, lievies, etc. on the supply/ work contract as per existing laws and to do liaison work required for obtaining necessary delivery clearance/ transit permits, etc., Bank may assists by giving application, if required, to state authority for any statutory permission for delivery of materials to banks premises. All statutory payments shall be made by tenderer/ contractor in this regard. The same will be refundable on production of valid receipts from the concerned authority.
11. The payment for the system will be made by NABARD, Lucknow to which the LCD projector is supplied and installed. The dispute arising out of the contract will also be sorted out within the jurisdiction of Lucknow Court of Law.
12. The contractors shall submit all technical details drawings, schematics etc. of the system along with the tender. The tenderers are requested to use the enclosed proforma only for this purpose. However, if they wish to submit any additional information/ details they may do so on a separate sheet.
13. The tenders shall give the names and postal address of their bankers and also the full name and postal address to whom similar equipment's have been supplied/ maintained by them.
14. The successful tenderer shall, if so required by the NABARD, train the NABARD's personnel at their factory in proper upkeep, repairs and trouble shooting of the system free of cost.
15. It is one of the conditions that the tenderer should have service facility preferably at Lucknow.



Extension of time

16. Under exceptional adverse climatic conditions, or other specific circumstances like force majors of any kind whatsoever, which may occur other than through a default of the contractor/tenderer be such as entitles extension of time for the completion of supply and works. Contractor/ tenderer shall notify to NABARD well in time to ascertain the period of such extension time to be granted.

C.D. for delay

17. If the supplier fails to comply and complete the work within the stipulated time or within the extended time given due to circumstances beyond the control of the supplier. The contractor/ tenderer shall pay to the Bank on demand, without prejudice to bank's right and remedies. NABARD may impose liquidated damages @ 1/2% (0.5%) of the contract amount for such defaults. The total amount of LD shall not exceed 5% of the contract amount.
