2 In the above context we invite sealed quotations for providing consultancy services to conduct Nondestructive tests (NDTs) of our buildings and to submit a detailed report including the various findings together with suggested remedial measures to arrest the deterioration , if any and also to submit Bill of Quantities (BOQ) to enable NABARD to undertake suggested measures to rehabilitate our buildings. Incidentally, providing a structural fitness certificate on completion of repairs / rehabilitation if any, shall form part of consultancy service.

3 In case you are interested you may send your most competitive offer in a sealed cover indicating item-wise rates and total amount for the comprehensive consultancy services mentioned above.
