Estimated Cost of the project is given for the purpose of arriving absolute figure in price bid. However, the total fee payable to the consultant shall be calculated as percentage (as quoted in the price bid part of this e-tender) of the actual project cost on completion of the work. GST shall be paid extra as applicable. TDS on IT and GST will be deducted as applicable.”
