#### **Preface**

National Bank for Agriculture and Rural Development (NABARD) is a body corporate constituted and established under an Act of Parliament namely the National Bank for Agriculture and Rural Development Act, 1981 ("NABARD Act") and carries on its activities *inter-alia* of providing credit for rural and agriculture development, including providing refinancing facilities. The Central Government holds 100% equity in NABARD. NABARD is having its Head Office at Bandra Kurla Complex, Bandra (E), Mumbai 400045, Maharashtra and Regional offices at 32 locations all over India.

NABARD intend to dispose of some of its surplus properties located at Lucknow (Uttar Pradesh), Bengaluru (Karnataka) and Mohali (Punjab) on "as is where is basis". #### **Scope of Work of Property Consultant**

- i. To provide consultancy services for disposal of residential premises on outright sale under NABARD's supervision and guidance.
- ii. To obtain non-encumbrance certificate, if any and other related clearances from authorities.
- iii. To draw conceptual plan for suitable options and shall prepare a roadmap for sale of properties.
- iv. To appoint a representative at the location where the property is identified for sale to coordinate with local office of NABARD.
- v. To provide site survey plans, use and application of development control regulation and byelaws.
- vi. To give input which would enhance the realizable value of the property.
- vii. To provide list of registered valuers to NABARD for valuation of the property. NABARD will be at liberty to get the valuation done from one or more valuers at its cost. NABARD is not bound to get valuation done only from the list provided by consultant.
- viii. To carry out brief analysis to arrive at reserve price of the property by ascertaining circle rate, market rate and valuation of the property. Collecting and submitting documents to support the above analysis.
  - ix. To provide list of e-auction platform or engage e-auction service providers approved by Government of India.
  - x. To associate with NABARD and give recommendations for acceptance of bids and disposal of property.
  - xi. To carry out related processes such as realistic valuations, scrutiny of bids, resolving legal issues involved if any and handling post sale documentation / registration etc.
- xii. To help NABARD with wide publicity for the sale of properties.
- xiii. To help NABARD liaisoning /concluding transactions as per the requirement of the Bank.
- xiv. To carry out other related activities as may be deemed necessary from time to time, as decided by Bank.
