Subject: ACABC Partnership Claims - Clarification Required – reg.

Please refer to your email dated 14.02.2023 on the above cited subject. In this regard, it is to inform that as per para 5.2.1, the TFO ceiling is calculated as per the “per trained person” with overall ceiling of Rs.100.00 lakh. Hence, percentage of subsidy may also be considered as per the category of individuals, in case of joint venture. In the present case, eligible TFO may be considered for Rs.40.00 lakh and subsidy @36% of Rs.20.00 lakh for male and @44% of Rs.20.00 lakh for female candidate separately. Thus, the total subsidy in this case would be Rs.16.00 lakh (Rs.7.20 lakh of male candidate + Rs.8.80 lakh of female candidate). The details of other cases are as under:

S. No.	Group Project Scenario	% of TFO to be taken for subsidy	Funds to be utilized from which category? (General/ SC/ST/NER)	How to include it in MIS/MPR? (Male/Female/ SC/ST)
1	2 members – 1 male, 1 female – Both general	Rs.20.00 lakh TFO for each member	From General category	As a Joint venture and as per individual's category
2	2 members – 2 male – One general, One SC	Rs.20.00 lakh TFO for each member	50% from general & 50% from SC	As a Joint venture and as per individual's category
3	2 members – 2 male – Both SC	Rs.20.00 lakh TFO for each member	From SC category.	As a Joint venture and as per individual's category

Wherever the TFO is less than Rs.20.00 lakh per individual in case of joint venture, the total TFO would be equally divided among the total members to arrive at the eligible TFO per individual.

This issues with the approval of competent authority.
