- 1. The bidders are advised to submit the tender strictly based on the General terms & conditions of the Contract and Technical Specifications contained in the tender documents, and not to stipulate any deviations. If acceptance of the terms and conditions given in the tender documents has any price implications, the same should be considered and included in the quoted price. Tender containing deviations from the terms and conditions shall be rejected at the Bank's discretion.
- 2. Please note that the Pre-Contract Integrity pact is invariably to be submitted along with the Part -I of the tender. Tender without pre-contract integrity pact shall be liable for rejection.

3. Submission of Tender:

- a. Bidders are advised to use only the forms issued by NABARD. However, if they desire to submit additional information, they may do so on their own letter head / paper. Each page of the forms shall be signed by the bidders. Insertions, postscripts, additions and alterations shall not be valid unless confirmed by the bidder's signature.
- b. **Part I Technical Bid** This part shall contain the covering letter, unpriced tender consisting of complete technical specification and commercial terms and conditions. Part I of the tender shall also contain the following:

- c. **Part II Financial Bid** This part is duly priced schedule of rates. This part shall contain prices in Indian Rupees only as per format (Part II). No other enclosure is permitted in Part II. Change of terms and conditions and technical deviations, if any, found in Part II of the tender will not be taken into account and will be treated as null and void. Tender in which prices are quoted in any other currency will not be considered.
 - i. This contract is neither a fixed lump sum contract nor a piece work contract but is a contract to carry out the work in respect of provision of the tender to complete in all respect.

- ii. Bills to be paid for according to actual measured quantities at the rates/quantities provided in the schedule of rates.
- iii. The rates quoted shall be deemed to be for the finished work and shall be firm and binding without any escalation whatsoever till the completion of work.
- iv. The item rate shall be workable and inclusive of all material and labor cost as well as contractor profit, overheads/Income Tax/GST as applicable.
- 4. If for any reason, it is found that the technical bid reveals the Financial Bid related details in any manner whatsoever, or, the Financial Bid is swapped in the file marked "Technical Bid", the Bid document will be rejected.
- 5. The contractor should have valid GST registration. While raising RA/final bills, the contractor should write their GSTIN number in the Tax Invoice and should also clearly indicate applicable GST amounts payable. Any changes in the GST rate prevailing shall be applicable on the quoted rates.
- 6. The Bidder will be selected on the basis of total composite score obtained during Quality Cum Cost Based Selection (QCBS) criteria.
- 7. The contractor has to quote for all the items of the tender. Incomplete tenders and tenders without EMD will be rejected.
- 8. All the measurements of the work shall be recorded by the contractor and the same shall be made available to the consultant/ officials of NABARD for verification.
- 9. The contractor should clean the work area and its area of influence on a daily basis. Further, the contractor shall remove all the debris of work from the works to the designated place inside the premises and dispose periodically to the municipal dump yard. A certificate on daily cleaning and periodical disposal of debris from ACT shall be provided by the bidder along with the RA bills. The RA bills without attaching this certificate of ACT will not be accepted for processing by NABARD.
- 10. Bidder shall supply all tools, plants, labor and consumables etc. as required for executing the work as per tender.
- 11. During evaluation of technical Bid, NABARD representatives may visit the bidder's completed or on-going projects and contact his past clients for verification of information given by the bidder. On visiting the site if, representatives find quality of the work executed is not satisfactory, then it can lead to disqualification of the bidder. Besides this, the documents submitted by the bidder, if found to be fraudulent/ manipulated/ false/amended, the bidder shall be blacklisted for minimum period of 03 years for working in NABARD.
- 12. During the execution of work for monitoring and speedy implementation, contractor must deploy qualified personnel i.e., one civil/ interior site engineer and an Electrical site engineer having experience in executing the similar works for day-to-day supervision.
- 13. A qualified project manager having sufficient experience in similar projects should be deployed by the bidder for overall site management, quality control, liaison with NABARD/ Consultant, timely implementation and attending program review meeting.

- 14. **SITE VISIT:** The bidder should visit and examine the site of works and its surroundings and obtain all information that may be necessary for preparing the Bid and entering into a contract for the said works. The costs of visiting the Site shall be at the bidder's own expense.
- 15. The bidder should also produce original documents for verification if called for. Failure to attach requisite documents with application will lead to disqualification of bid without any intimation.
- 16. The application form shall be uploaded in CPPP *https://eprocure.gov.in* after duly filled and signed on each page of tender. Incomplete tender liable to be rejected.
- 17. Application containing false and/ or incomplete information is liable for rejection and consequences.
- 18. The application must be submitted in the Pro-forma without editing the text whatsoever. Any Violation of this condition shall render the application invalid.
- 19. The tenders shall be signed by the person/persons on behalf of the Organization having the necessary Authorization/Power of Attorney to do so. (Copy of Power of Attorney/Memorandum of Association shall be furnished along with application, if required).
- 20.If the space in the Pro-forma is insufficient for furnishing full details, such information shall be supplemented on separate sheets of paper stating therein the part of the Pro-forma and serial number. Separate sheets shall be used for each part of application, if required.
- 21. Tenders containing false and/or incomplete information are liable for rejection.
- 22. The contractor must have qualified and experienced professionals in the respective disciplines. Details of the same may be shared with NABARD (Annexure -IV).
- 23. The bidder must have successfully completed the work according to the eligibility criteria under pre-qualification criteria.
- 24. Water & Electricity supply for work execution: The Bank may provide Water & Electricity. In case of non-availability of the same, contractor may arrange the cost on its own. All the necessary arrangements for electricity points i.e. cable, switch etc. contractor shall provide same.
- 25. The rates for each item as per scope of work shall be quoted by the applicant in the Financial Bid to be uploaded in the CPPP website.
- 26.All the protocols / guidelines related to COVID- 19 or other matters fixed by government to be followed by the contractor at his own cost.
- 27. **Taxes, Insurance & Other Charges :** The prices quoted for the work shall be deemed to have included all taxes, custom duty, excise duty, GST or any other taxes/duties imposed by /State Government/ Local Bodies/ Central Government, charges for labor, transport, insurance charges for transit, shipment, packing, freight from the factory to the destination site, handling, clearing, installation, and commissioning charges, insurance charges for storage, erection, testing and commissioning, CAR policy (1.25 times the Contract Value), workmen compensation and third party liability etc. to commence from the 10 days after the

date of Work Order from NABARD till the issue of Virtual Completion Certificate. If the bidder (contractor) fails to include such taxes/duties/charges in the tender, no claim thereof will be entertained by NABARD afterwards. As per laws, income tax and GST-TDS etc. will be deducted at source and a certificate for the same will be issued to the contractor. The tendered rates shall be firm and shall not be subject to any variations, on account of fluctuations in the market rate or any other source.

- 28.Validity of Tender- The Tender along with the prices shall remain valid initially for a period of 90 days from the date of opening of Financial Bid (Part II) of tender, which period may be further extended by mutual agreement in writing by the bidder and the bidder shall not cancel or withdraw the tender during this period.
- 29. **Earnest Money:** The Tender must be accompanied by Earnest Money in the form of Direct Deposit in the Bank through NEFT OR Valid MSE registration certificate. Tender not accompanied by EMD OR Valid MSE registration certificate shall be rejected. Should the Invitation to Tender be withdrawn or cancelled by the Bank, which shall have the right to do so at any time, EMD will be returned.
- 30. **Initial Security Deposit (ISD)/ Security Deposit (SD)/Retention Money Deposit (RMD):** ISD of 2% of accepted value of tender shall be provided by the successful bidder through online transfer NEFT/RTGS within 15 days of issue of work order. The EMD already furnished by the successful bidder shall be taken into account while determining the above ISD. In other words, EMD will become part of ISD. The ISD will be liable to be forfeited in case the Contractor commits breach of any of the terms and conditions of the Contract or fails to complete the works. This forfeiture is independent of the liquidated damages provided for in the Contract. The initial security deposit amount will be adjusted or included in the retention money as per sub-Clause herein below.

Security Deposit (SD)/Retention Money Deposit (RMD):

- i. Earnest Money Deposit and Retention Money Deposit will form a total Security Deposit (SD). The security deposit will be 5% of the total value of work executed. RMD shall be deducted 5% from every R.A. Bill till the total recovery amounts including EMD/ISD amounts to 5% of the contract amount.
- The 50% of Security Deposit will be refunded after the expiry of defect ii. liability period, provided the Contractor has satisfactorily carried out all the rectification works and attended to all defects and facilitate content integration in association with "Corporate Communication Department (CCD) of NABARD/Content Development Vendor appointed by CCD" to the satisfaction of NABARD at the quoted rate for "Content Repurposing and Programming" in the tender. Remaining 50% SD shall be released against submission of Bank Guarantee for 05 years from DLP against the same amount (Proforma in Annexure – XIV) co-terminus with the expiry of Comprehensive Annual Maintenance Contract (CAMC) for 5 years from the date of expiry of DLP. During the period of CAMC, the bidder shall integration facilitate content in association with "Corporate

Communication Department (CCD) of NABARD/Content Development Vendor appointed by CCD" to the satisfaction of NABARD at the quoted rate for "Content Repurposing and Programming" in the tender.

- 31. **Defect Liability Period:** Defect Liability Period shall be 01 year from the date of virtual completion as certified by the consultant and approved by NABARD. All repair costs during aforesaid Defects Liability Period shall be borne by the Contractor at his risk and cost. If the Contractors do not carry out the rectification work during the Defects Liability Period, then NABARD shall have the right to get such defective work rectified after giving due notice in writing to the Contractor/s and recover the cost of such repairs from the RMD/Security Deposit amount so retained.
- 32. **Right to Accept Part Tender:** NABARD reserves the right to accept the tender either in whole or in part at the same prices quoted by the bidder.
- 33. Labor stay at site: No Labor stay is allowed at work site.

34. Signing of Contract Agreement

- i. The General Conditions and special conditions, herein before referred to, Conditions of Contract and Technical Specifications, schedule of works enclosed with the tender documents and the subsequent correspondence exchanged between NABARD and the bidder shall be the basis of the Work Order/final contract to be entered into with the successful tenderer.
- ii. The bidders shall go through the terms and conditions given in the general conditions of contract herewith and bidders' offer shall be strictly in line with the terms specified therein. No deviation from the terms and conditions specified shall be acceptable.
- iii. On receipt of intimation from NABARD of the acceptance of his/their tender, the successful bidder shall be bound to implement the Contract and within 14 days thereof, the successful bidder shall sign an agreement in accordance with the articles of agreement. Notwithstanding the signing of the agreement, the written acceptance by NABARD of a tender in itself will constitute a binding contract between NABARD and the successful bidder, whether such agreement is or is not subsequently executed. The stamp duty charges will have to be borne by the contractor (bidder).
- iv. The contractor shall not assign the contract to any third party. He shall not sublet any portion of the contract except with the written consent of NABARD. In case of breach of these conditions, NABARD may serve a notice in writing to the Contractor rescinding the contract whereupon the security deposit shall stand forfeited to NABARD, without prejudice to his other remedies against the Contractor.

35. Inspection of materials/work at site:

- i. NABARD at its discretion may inspect the material at site or elsewhere. However, all cost towards inspector's travelling, lodging, boarding if any would be borne by NABARD.
- ii. NABARD's officials shall have free and full access at any time during execution of the contract to the contractor's works or work site in case of

the execution of work for the aforesaid purpose, and he may require the contractor to make arrangements for inspection of work or any part thereof or any material at his premises or at any other place specified by NABARD's officials and if the contractor has been permitted to employ the service of a sub-contractor, reserve to NABARD's officials a similar right.

- iii. The above will, however, not in any way absolve the contractor of his responsibility about proper performance of the system/ components after erection and commissioning at the designated place.
- iv. NABARD's officials carrying out the inspection shall have the power to certify/ accept/ reject as follows:
 - a. To reject any material or parts submitted as not being in accordance with the specification.
 - b. To mark the rejected material with a rejection mark so that it may easily be identified if re-submitted.
- 36. **Completion Period:** Time allowed for carrying out the work is 4 months which shall be strictly observed by the Contractor, and it shall be reckoned from the 10th day after issuing the Work Order. The work throughout the stipulated period of the contract should proceed with all the due diligence and if the contractor fails to complete the work within the specified period, he shall be liable to pay liquidated damages as defined in the tender. The bidder may, before commencing the work, prepare a detailed work program in the form of Bar Chart and submit to NABARD for approval. The bidder may indicate the time schedule as per the broad items of work listed below. The Bar Chart thus submitted shall be for completion of the work within the contractual completion period from the 10th day of Work Order. Such chart may include all activities like the date of supply of material at site, completion of work etc. NABARD may provide open storage space within the compound of the building. However, the responsibility and safety of the materials stored will be with the contractor. No accommodation will be provided for any worker by NABARD. The partitions/ enclosure for the proposed site shall be erected by the vendor at his cost and shall be dismantled upon completion of work and all dismantled materials to be disposed outside municipal limits by the contractor at his risk and cost.
- 37. **Insurance:** On or before the date of commencement of the contract, the contractor shall take all insurances at his cost covering all kinds of risks till end of defect liability period of the work, in the joint names of NABARD and the contractor (NABARD's name being first) and it shall take at least the following risk related policies:- Contractor's All Risk Policy at 1.25 times of the value of the contract. Workmen compensation policy for all the workmen of the contractor at site.

Note:

i. These policies shall remain valid for all the time during the currency of the contract till end of defect liability period. If these policies are not provided by the contractor, NABARD reserves the right to take the above insurance

policies themselves and/ or recover the cost thereof from the payables the contractor.

- ii. The Contractor shall provide NABARD with documentary evidence from time to time, that he has taken all the insurance policies mentioned in the foregoing paragraphs and that he has paid the necessary premium for keeping the policies valid till the expiry of defect liability period.
- iii. The Contractor has to Add-on covers under this policy, if at all they are not included under the original policy like:
 Clearing and removal of debris; Damage to surrounding property not forming part of the contract work. Maintenance visit / extended maintenance cover to cover accidental loss or damage whilst carrying out any rectification during maintenance period and / or any amount incurred for rectification of such original defects or faults during construction.
- 38. **Governing Laws and Dispute Resolution** The Tender and selection process shall be governed by and construed in accordance with the laws of India and shall be subject to exclusive jurisdiction of courts in Mumbai only. Disputes or differences whatsoever, arising out of the Tender process shall be resolved hereunder:
 - i. All disputes and differences of any kind whatsoever, arising out of or in connection with the Tender in respect of execution of the work shall be resolved amicably.
 - ii. In case of failure to resolve the disputes and differences amicably within 30 days of the receipt of notice by the other party, then such unsettled dispute or difference shall be referred to arbitration by sole arbitrator mutually agreed in accordance with the Arbitration and Conciliation Act, 1996.
 - iii. If no agreement is arrived at within 30 days from the date of notice as to who shall be the sole arbitrator, NABARD shall send to the bidder a list of three names of persons who shall be presently unconnected with NABARD. The Bidder shall on receipt of the names as aforesaid, select any one of persons so named to be appointed as sole arbitrator and communicate his name to NABARD within 30 days on receipt of the names. NABARD shall thereupon without delay appoint the said person as the sole arbitrator.
 - iv. If the bidder fails to select the person as sole arbitrator within 30 days of receipt of the panel and inform NABARD accordingly, NABARD shall be entitled to appoint one of the persons from the panel as sole arbitrator and communicate his name to the bidder.
 - v. If the person so appointed is unable or unwilling to act or refuses his appointment or vacates his office due to any reason whatsoever, another person shall be appointed by NABARD from the above list of persons. The provisions of the Indian Arbitration and Conciliation Act, 1996, shall govern the arbitration.
 - vi. The award shall be final and binding on both the parties.

- vii. It is hereby agreed that in all disputes referred to the Arbitration, the Arbitrator shall give a separate award in respect of each dispute or difference in accordance with the terms of reference and the award shall be a reasoned award. It is hereby agreed that the Arbitrator shall not have powers to order any interim measures whatsoever during the course of arbitration.
- viii. The fees, if any, of the Arbitrator shall initially be paid in equal proportion by each of the parties. The cost of the reference and of the award including the fees, if any, of the Arbitrator shall be directed to be finally borne and paid by such party or parties to the dispute in such manner or proportion as may be directed by the Arbitrator as the case may be in the award.
 - ix. The place of arbitration shall be at Mumbai.
 - x. The language of the proceedings shall be in English.

39. Other Issues

- i. The Contractor shall carry out all the work strictly in accordance with the instructions of authorized representative of NABARD/ consultant. If in the opinion of NABARD, nominal changes have to be made to suit the site condition and with the prior approval in writing of NABARD, they desire the Contractor to carry out the same, the Contractor shall carry out the same without any extra charge.
- ii. The contractor must obtain for himself on his own responsibility and at his own expense, all the information which may be necessary for the purpose of making a tender and for entering into a contract and must examine the drawings, inspect the site of the work, and acquaint himself with all local conditions, means of access to the work, nature of the work and all matters pertaining thereto. NABARD's decision in such cases shall be final and shall not be open to arbitration.
- iii. A Schedule of Probable Quantities in respect of each work and Specifications accompany these Conditions. The Schedule of Probable Quantities is liable to alteration by omissions, deductions or additions at the discretion of NABARD.
- iv. The rates quoted in the tender shall include all charges for scaffoldings, watching and lighting by night as well as day including Saturdays/Sundays and holidays, protection of all other erections, matters or things and the Contractor shall take down and remove any or all such centering, scaffolding etc. as occasion shall require or when ordered so to do, and fully reinstate and make good all matters and things disturbed during the execution of work and to the satisfaction of NABARD.
- v. The contractor shall not be entitled to any compensation for any loss suffered by him on account of delays in commencing or executing the work, whatever the cause of delays may be, including delays arising out of modifications to the work entrusted to him or in any sub-contract connected therewith or delays in awarding contracts for other related work i.e. "Contract for Content Development" of the project or in commencement

or completion of such works. NABARD does not accept liability for any sum besides the tender amount, subject to such variations as are provided for herein.

- vi. The successful bidder is bound to carry out all items of work necessary for completion of the job even though such items are not included in the quantities and rates. Schedule of instruction in respect of such additional items and their quantities will be issued in writing by NABARD.
- vii. The contractor must bear in mind that all the work shall be carried out strictly in accordance with the specifications made by NABARD.
- viii. Confidentiality: The Contractor shall treat the details of the Contract as private and confidential, except to the extent necessary to carry out obligations under it or to comply with applicable Laws. The Contractor shall indemnify NABARD for any loss suffered by them as a result of disclosure of any confidential information. The Contractor shall not publish, permit to be published, or disclose any particulars of the Works in any trade or technical paper or elsewhere without the written permission of NABARD.

V. SPECIAL CONDITIONS

- 1. The Contractor should note that unless otherwise stated the tender is strictly on item rate basis and his attention is drawn to the fact that rates for each and every item should be correct, workable and self-supporting. The quantities in the schedule of quantities approximately indicate the total extent of work but may vary to any extent and may even be omitted thus altering the aggregate value of the Contract. No claim shall be entertained on this account.
- 2. The Security Deposit of the successful tenderer will be forfeited if he fails to comply with any of the conditions of the Contract.
- 3. **CONTRACTOR'S LIABILITY AND INSURANCE**: From commencement to completion of works, the Contractor shall take full responsibility for the care of the work and for taking precautions to prevent any loss or damage to the works and shall be liable for any damage or loss or theft that may arise to the works or any part thereof from any cause whatsoever, inherent defects and failures due to poor workmanship and causes such as lightning, explosion, earthquake, storm hurricane, floods, inundation, riots excluding civil war, rebellion, revolution and insurrection and shall at his own cost repair and make good the same so that at all times the work shall be in good order and condition and in conformity in every respect with the requirements of the Contract.

Explanation: For the purpose of this condition, the expression "from the commencement to completion of work" shall mean the time commencing from the issue of the work order to the contractor and ending with completion of defect liability period.

- 4. Without limiting the obligations and responsibilities under this condition, the Contractor shall insure and keep insured the works from commencement to completion, as aforesaid 1.25 times the contract value against the risk of loss or damage from any cause whatsoever including the causes enumerated in the forgoing Clauses above. In the event of there being a variation in the nature and extent of the work, the Contractor shall from time to time increase or decrease the value of the insurance correspondingly. All the premium shall be borne and paid by the contractor. The said insurance shall also provide for the removal of debris of the lost or the damaged works. The said insurance shall be in the joint name of the Employer (NABARD) and the Contractor, The Employer's name being mentioned first in the policies and the Contractor should deposit with the Employer the said policy or policies before commencing the work at site. All money payable by the insurers under such policy or policies shall be recovered by the Employer and shall be paid to the Contractor or any other agency of Employer's choice in instalments for the purpose of rebuilding or replacement or repairing the works and/or goods destroyed or damaged as the case may be.
- 5. If the Contractor has a blanket insurance policy for all the works to be executed by him and the policy covers all the items to be insured under the condition, the said policy shall be assigned by the Contractor in favour of the Employer, provide however that if any amount is payable under the policy by the insurers in respect of

works other than the work under the Contract, the same may be recovered by the Contractors directly from the insurers.

- 6. The contractor shall indemnify and keep indemnified the Employer against all losses and claims, damages or compensation under the provision of the payments of Wages Act 1936, Minimum Wage Act 1948, Employer's Liability Act 1938, Workmen's Compensation Act 1923, the Maternity Benefit Act 1961, Bombay Shops and Establishment Act 1947, Industrial Dispute Act 1947, and the Contractor Labour (Regulation and Abolition) Act, 1970 and Employee's State Insurance Act or any modification thereof or any other law relating thereto and rules made there under from time to time or as consequence of any accident or injury to any workmen or other person in or about the work whether in the employment of the employer or Contractor or not, and also against cost, charges and expenses of any suit, action or proceedings whatsoever out of such accident or injury of combination or any such claim.
- 7. Before commencing the work, the Contractor shall without limiting his obligations and responsibilities under this condition, insure against any loss of life or injury to any personnel in the Employment of Contractor/sub- Contractor. For this purpose, an insurance shall be taken by the contractor or sub-contractor. Such an insurance shall be taken to include both employees/workmen covered by Workmen's Compensation Act 1923, as well those employees/workmen not covered by the said Act. Separate insurance policies shall be taken for employees/workmen covered by Workman's Compensation Act 1923, and Employees /workmen not covered by the said Act. All the premium shall be paid by the Contractor. Policy/policies taken under this clause for the personnel in employment with the Contractor/Sub-Contractor/ nominated sub- Contractors, may be in their Employer's names of the Contractors/sub-Contractors. In the event of any loss or injury to the personnel in employment with the contractors/sub-contractors, the Employee and the Contractor shall recover directly from the Insurance Company and ensure that payment of the same is made to the affected parties. The policy in original shall be deposited with the Employer.
- 8. The Contractor shall at all-time indemnify and keep indemnified the Employer against all losses and claims for injuries or damage to any person or any property whatsoever which may arise out of or in consequence of the construction and or rehabilitation/repair and during the defect liability period and against all claims, demands, proceedings, damages, costs, charges and expenses whatsoever in respect of and in relation thereto. Before commencing the execution of the works, the Contractor shall without in any way limiting his obligations and liabilities under this condition, insure at his cost and expense against any damage or loss or injury which may be caused to any person or property including the Employee or servants of the Employer and the Consultants and their property by or in the course of the execution of the works.
- 9. The Contractor shall provide the Employer with documentary evidence from time to time, that he has taken all the insurance policies mentioned in the foregoing

paragraphs and that he has paid the necessary premium for keeping the policies valid till the expiry of defects liability period.

- 10. If the Contractor and/or his sub- Contractor or nominated Contractor, if any shall fail to effect and keep in force the insurance referred to above or any other insurance which he/they may be required to effect under the terms of the Contract, then in any such case, the Employer may, without being bound to effect and keep in force any such insurance policy and pay such premium or premium, as may be necessary for that purpose from time to time and deduct the amount so paid by the Employer from any moneys due or which may become due to the Contractor or recover the same as a debt due from the Contractor.
- 11. The Contractor shall indemnify NABARD by giving suitable Indemnity Bond as per NABARD's pro forma attached herewith (Annexure XI).
- 12. **SCHEDULE OF QUANTITIES:** The Schedule of the Quantities unless otherwise stated shall be deemed to have been prepared in accordance with the standard procedure of the authorized representative of NABARD and shall be considered to be approximate and no liability shall attach to the authorized representative of NABARD for any error that may be discovered therein. Further, it is the prerogative of NABARD to carry out the items entirely or partially of the BoQ. The contractor will not have any right to claim any additional cost if any items are removed by NABARD from the BoQ for execution.
- 13. **SUFFICIENCY OF SCHEDULE OF QUANTITIES:** The Contractor shall be deemed to have satisfied himself before tendering as to the correctness and sufficiency of his tender for the works, and of the prices stated in the Schedule of Quantities and/or Schedule of Rates and prices, which rates and prices shall cover all his obligations under the Contract, and all matters and things necessary for the proper completion of the work.
- 14. CONTRACTOR ТО PROVIDE EVERYTHING NECESSARY :The Contractor shall provide everything necessary for the proper execution of the works according to the true intent and meaning of the Drawings, Specifications and Schedule of Quantities taken together whether the same may or may not be particularly shown or described therein, provided that the same can be inferred there from and if the Contractor finds any discrepancy in the Drawings or between the Drawings, Specifications and Schedule of Quantities he shall immediately refer the same in writing to the Employer, who shall decide which shall be followed, and employer's decision shall be final and binding on all parties. The Contractors will supply, fix and maintain at his cost during the execution of any works, all the necessary centring, scaffolding, staging, timbering, strutting, shoring, pumping, fencing, hoarding, watching and lighting by night as well as by day required not only for the proper execution and protection of the public and safety of any adjacent roads, streets, cellars, vaults, pavements, walls, houses, buildings and all other erections, matters or things. The Contractor shall pull down and remove any or all such scaffolding, after completing his work as occasion shall require or when ordered to do so and shall fully reinstate and make good all matters and things disturbed during the execution of the works, to the satisfaction of the Consultant /

Employer.

- 15. AUTHORITIES, NOTICES, PATENTS, RIGHTS & ROYALTIES The Contractor shall conform to the provisions of all the statutes relating to the works, and to the Regulations and bye-laws of any local Authority, and of any Water, Lighting of other Companies or Authorities with whose systems the structure is proposed to be connected, and shall before making any variation from the drawings or specifications that may be necessitated by so conforming, give to the Bank's Officer written notice, specifying the variations proposed to be made and the reason for making it, and apply for instruction thereon. In case the Contractor shall not within ten days receive such instructions, he shall proceed with the work conforming to the provisions, Regulations or Byelaws in question.
- 16. The Contractor shall bring to the attention of the authorized representative of NABARD all notices required by the said Acts, Regulations of Byelaws to be given to any Authority by the NABARD and pay to such Authority, or to any Public Officer, all fees that may be properly chargeable in respect of the works, and lodge the receipts with the authorized representative of NABARD
- 17. The Contractor shall indemnify the Employer against all claims in respect of patent rights, design, trademarks of name or other protected rights in respect of any plant, machine work or material used for or in connection with the works or temporary works and from against all claims, demands, proceedings, damages, costs, charges and expenses whatsoever in respect thereof or in relation thereto. The Contractor shall defend all actions arising from such claims, unless he has informed the authorized representative of NABARD, before any such infringement and received their permission to proceed, and shall himself pay all royalties, license fees, damages, costs and charges of all and every sort that may be legally incurred in respect thereof
- 18. MATERIALS AND WORKMANSHIP TO CONFORM TO DESCRIPTION: All materials and workmanship shall, so far as procurable, be of the respective kinds specified in the Schedule of Quantities and/or specifications and in accordance with the instructions of authorized representative of NABARD and the Contractor shall upon the request of the authorized representative of NABARD furnish to them all invoices, accounts, receipts and other vouchers to prove that the materials comply therewith. The Contractor shall at his own cost arrange for and/or carry out any test of any materials which the Bank (NABARD) may require. The Specifications shall wherever not mention in the tender be taken in accordance with the latest CPWD Specifications and its latest revision or BIS, if any. If the Contractor contends that any of the material, goods or workmanship specified as aforesaid, is unobtainable, he shall submit to the clients, his grounds for his contention, and thereupon, NABARD shall decide whether the same is unobtainable in fact. If NABARD shall decide that any of the materials, goods or workmanship is in fact unobtainable, they shall issue an order in writing as what is to be substituted thereof, and such order shall be deemed to be an order for variation; such order shall however be got approved by NABARD before issue.
- 19. SETTING OUT: The Contractor shall at his own expense, set out the works,

accurately in accordance with the plans and to the complete satisfaction of NABARD. The Contractor shall be solely responsible for the true and perfect setting out of the works, and for the correctness of the position, levels, dimensions and alignment of all parts thereof. If at any time any error shall appear during the progress or on completion of any part of the work, the Contractor shall at his own cost rectify such error if called upon, to the satisfaction of NABARD. authorized representative of NABARD/Consultant shall from time to time inspect the work, but such inspections shall not exonerate the Contractor in any way from his obligations to remedy any defects which may be found to exist at any stage of the work or subsequently after the same is completed.

- 20. Content Repurposing and Programming shall be carried out by the contractor on receipt of contents from Corporate Communications Department (CCD) of NABARD and in consultation with CCD during the defect liability period (DLP) and CAMC period. The contractor shall be paid for this work at this quoted price in this tender. During the Contract period, the payment towards this shall be paid by us on certification of bills by the consultant and CCD of NABARD.
- 21. **DISMISSAL OF WORKMEN:** The Contractor shall on the instruction of the NABARD/ Consultant immediately dismiss from the works any person Employed there-on who may, in the opinion of the NABARD, be unsuitable or incompetent or who may misconduct himself and such person shall not again be employed or allowed on the works without the permission of NABARD.
- 22. ACCESS TO WORKS: The Consultant and the authorized representative of NABARD shall at all reasonable times have free access to the works, and to the workshops, factories or other places where materials are being manufactured or fabricated or stored or displayed for the Contract and also to any place where the materials are lying or from which they are being obtained. The Contractor shall give every facility to the authorized representative of NABARD and consultant for inspection and examination and test of the materials and workmanship. No person unless authorized by NABARD, except the Representatives of Public Authorities, shall be allowed on the works at any time. If any work is to be done at place other than the site of the works, the Contractor shall obtain the written permission of the Bank for doing so.
- 23. **MEASUREMENT OF WORKS:** The authorized representative of NABARD / Consultant may from time to time intimate the Contractor that he requires the works to be measured and the Contractor shall forthwith attend or send a qualified Site Engineers posted at site to assist the authorized representative of NABARD or their representative in taking such measurements and calculations and to furnish all particulars or give all assistance required by either of them. Should the Contractor not attend or neglect or omit to send such agent, then the measurements taken by the authorized representative of NABARD or approved by him shall be taken to be the correct measurements. The works shall be measured according to the mode of measurements stated in the specifications. The measurement shall wherever not mention in the tender be taken in accordance with the Indian Standard of "Method of Measurement, if any". The Contractor or his Agent may at

the time of measurement take such notes and measurements as he may require.

- 24. **PRICES FOR EXTRAS ETC. ASCERTAINMENT OF:** Should it be found after the completion of the works from measurements taken in accordance with the previous paragraph that any of the quantities or amounts of works thus ascertained are less or greater than the amounts specified for the works in the priced Schedule of Quantities and/or that any variation is made, the valuation thereof, unless previously or otherwise agreed upon, shall be made in accordance with the following rules:
 - i. The net rates or prices in the original Tender shall determine the valuation of the extra work where extra work is of a similar character and executed under similar conditions as the work priced therein.
 - ii. The net rates or prices in the original tender shall determine the value of the items omitted, provided if omissions vary the conditions under which any remaining items of works are carried out, the prices for the same shall be valued under (iii) hereof.
 - iii. Where the extra works are not of similar character and/or not executed under similar condition as aforesaid or where the omissions vary, the conditions under which any remaining items of works are carried out or if the amount any omission or additions relative to the amount of the whole of the Contract works or to be any part thereof shall be such that in the opinion of the authorized representative of NABARD the net rate or price contain in the priced Schedule of Quantities or tender or for any item of the works involves loss or expenses beyond that reasonably contemplated by the Contractor or is by reason of such omission or addition rendered unreasonable or inapplicable, the authorized representative of NABARD shall fix such other rate or prices as in the circumstances considers reasonable and proper, on the basis of actual rate analysis for cost of work involved plus fifteen percent towards contractor's overhead and profits, which shall be final and binding on the contractor. The rate analysis to be approved by the Bank before finalization of such rates.
- 25. **BASE PRICE:** Wherever Base Price of the materials insisted in the items of work in the BoQ, this price is inclusive of GST. If the basic price of the material selected and procured against the item of work is less than or more than 5% of the specified basic price, difference in cost will be deducted or added from/to the respective item of work. The bidder shall submit tax invoice of the materials procured where the basic prices are insisted in the tender.
- 26. **REMOVAL OF DEFECTIVE WORK AND MATERIALS** :The authorized representative of NABARD shall, during the progress of the works, have power to order in writing from time to time the removal from the works, within such reasonable time as may be specified in the order, of any materials which, in the opinion of the authorized representative of NABARD are not in accordance with the specifications or the instructions of the authorized representative of NABARD. The contractor shall substitute the defective materials with proper materials and properly re-execute such defective work which has been executed, with materials

or workmanship in accordance with the Drawings and Specifications or instructions at his own cost. In case of default on the part of the Contractor to carry out such order the Employer shall have power to employ and pay other persons (third party) to rectify the defective work and all expenses consequent thereon or incidental thereto shall be borne by the Contractor, and shall be recoverable from him or will be deducted by NABARD (Bank) from any money due or that may become due to the Contractor. If the correcting works are not done in accordance with the contract, NABARD may allow such work to remain and, in that case, NABARD shall work out the deduction to be applied to the quoted rate together with such further allowance for damages to the Employer, as may be reasonable which shall be binding on the contractor.

- 27. **MAKES AND INDICATIVE MODELS:** Options of Makes and indicative models of the items given in the Technical Specifications are only for reference while quoting the tender. However, final selection and approval of make and model will be done by NABARD. The bidder shall procure the items only after approval of NABARD.
- 28. DEFECTS AFTER COMPLETION : Any defect may appear within the "Defects Liability Period" stated in the Appendix hereto or if none stated, then for a period of one year after the Virtual Completion of the work and responsibility for making good at their own cost of the latent/patent imperfections or defect becoming apparent during this period arising in the opinion of the authorized representative of NABARD from materials or workmanship, shall upon the directions and writing of the authorized representative of NABARD, and within such reasonable time as shall be specified therein, be attended and made good by the Contractor, at his cost. In case of default the Employer may employ and pay other persons (third party) to attend and make good such defects, or faults, and all damages, loss and expenses consequent thereon or incidental thereto shall be recovered from the Contractor by the Employer (NABARD) or may be deducted by the Employer upon the Bank's Officer Certificate in writing from any moneys due or that may become due (including Security Deposit) to the Contractor.
- 29. **DELAY AND EXTENSION OF TIME -** If in the opinion of the NABARD the works be delayed
 - i. by force majeure or
 - ii. by reason of any exceptionally inclement weather or
 - iii. by reason of proceedings taken or threatened by the dispute with adjoining or neighbouring owners or public authorities arising otherwise than through the Contractor's own default or
 - iv. by the works or delays of other Contractors or tradesmen engaged or nominated by the Employer and not referred to in the Schedule of Quantities and/or Specifications or
 - v. by reason of employer's instructions, or
 - vi. by reason of civil commotion, local commotion of workmen or strike or lock-out affecting any of the building trades or in case of such strike or lock-out, the Contractor shall, as soon as may be, given written notice

thereof to the employer, but the Contractor shall nevertheless constantly use his endeavours to prevent delay and shall do all that may reasonably be required to the satisfaction of the employer to proceed with the work.

- vii. In consequence of the Contractor not having in due time necessary instructions from the Employer, for which he shall have specifically applied in writing, ahead of time, giving the employer reasonable time to prepare such instructions, the employer shall make a fair and reasonable extension of time for completion of the Contracted works. The Contractor shall take all practicable steps to avoid or reduce any delay in the execution and completion of the works.
- 30. **KEEPING SITE CLEAN -** The contractor shall at all times keep the site and it's influence area in the premises clean and shall dispose of all rubbish, debris and offensive material at his cost in a manner approved by the Employer and as per instructions of the Employer.

31. AVOIDANCE OF NUISANCE

- i. The contractor shall take all necessary precautions in reducing noise of plant by means of mufflers, silencers, screens, etc.
- ii. Work liable to create dust shall be well wetted before being executed.
- iii. The work shall be carried out strictly in accordance with the time schedule and other instructions given by NABARD taking care to cause minimum amount of noise, dust and another nuisance at the site.
- iv. The work site is located in the reception area of the functional office building. All the open sides of the worksite (location) should be properly covered temporarily from the floor level to ceiling level with plywood till the work is over in all respect to avoid the disturbance for smooth functioning of the office.
- 32.**TERMS OF PAYMENT:** The payment for the works carried out under this contract shall be made as follows:
 - i. No advance payment shall be made.
 - ii. Running Account (RA) Bills shall be paid to the contractor subject to a minimum value of ₹50 lakh per RA bill. Each RA bill/Final Bill shall be submitted by the contractor along with detailed measurements jointly taken by the contractor/consultant/ authorized representative of NABARD and a certificate issued by the Bank's Assistant Caretaker/Protocol & Security Officer confirming the cleanliness of the site and proper disposal of the debris.
 - iii. 15% of amount payable to AV system installations will be deducted from each RA Bill besides the statutory deductions such as RMD, ITTDS, GST TDS etc. This deducted amount will be released along with the payment against the Final Bill. The payment against final bill shall be released upon the successful testing & commissioning of AV/HVAC/Allied electromechanical system, installation of Content Management System Software & Content Repurposing and Programming, and final handover of the AV &

Allied System after complete measurement along with issuance of Virtual Completion Certificate by the Consultant and approved by the Bank. This phase includes thorough testing to ensure everything is functioning correctly, commissioning to bring the system into active service, and programming to meet the specific needs of the project.

VI Scope of Work

The contractor/ bidder shall completely carry out the said work in every aspect in strict accordance with this contract and with the directions of and to the satisfaction of the Bank. In order to complete the project in all respect, the bidder shall have to carry out the works as detailed below:

<u>General Scope of Works</u>

- i. The bidder shall carry out comprehensive interior work consisting of civil, electrical, structured cabling, HVAC works & Allied System Works as per the drawings provided by the Bank/ Architect/ consultant and BoQ item descriptions and specifications in the tender document.
- ii. After completion of interior works, the bidder shall supply, install, testing and commissioning of the Audio-Visual System as per the drawings approved by the bank/ architect/ consultant and item description in the BoQ of the tender document.
- iii. The bidder shall liaison with the AV consultant/architect, Corporate Communication Department (CCD) of NABARD and Content Development Vendor appointed by NABARD to develop Content Repurposing, Programming and Content Management System and facilitate smooth integration of the contents & software with the hardware (AV system) installed by him.
- iv. The bidder shall engage a qualified civil. / Interior site engineer/ supervisor and an electrical site engineer/ supervisor for implementing the project smoothly by ensuring quality and timely implementation as per the terms of the contract.
- v. The bidder shall assign a dedicated project manager who will oversee the entire project, ensuring effective coordination, timely completion, and adherence to project milestones, as agreed upon with the client. Maintain regular communication with NABARD, providing updates on project progress, addressing any concerns, attending periodic progress review meetings conducted by NABARD and facilitating smooth project execution. Employ efficient project management methodologies to monitor and control project costs, timelines, and resources, as defined in the tender document.
- vi. The bidder shall coordinate closely with the consultant and content development vendor appointed by NABARD to ensure the content is seamlessly integrated with the AV system and operates smoothly. This will involve the following:
 - a. <u>Content Integration and Testing</u>: The bidder shall ensure the integration of the content management system (CMS) with the AV system, verifying that the CMS software can seamlessly interact with the hardware. The bidder will conduct testing with the content management contractor to check the functionality and performance of all content across the entire AV system. This testing will involve playing back different content types such as video files, audio recordings, and interactive media on the system, ensuring that it meets all operational standards. The bidder will verify the real-time performance of the CMS under varied conditions, including multiple

content files, live streaming (if applicable), and interactions with users (e.g., touch-screen functionalities), ensuring no errors occur during operation.

- b. <u>Synchronization of Interactive Content:</u> In cases where the content involves interactive elements, such as VR booths, multi-touch tables, or interactive displays, the bidder must ensure that the AV system is fully synchronized with these content features.
- c. <u>Real-Time Content Updates and Integration:</u> The bidder will coordinate with the consultant, CCD and content development contractor to facilitate real-time content updates and integration into the AV system. This could involve implementing live feeds, dynamic content (e.g., real-time data visualizations) that can automatically update the content displayed across various AV components. The bidder should ensure the seamless integration of content changes and updates without disruption to the AV system's operation. Any content uploaded or updated in the CMS should automatically be reflected on the AV system across the networked devices (e.g., Active LEDs, displays, projectors).
- d. <u>Technical Support and Issue Resolution</u>: During the project lifecycle including comprehensive AMC period, if any technical issues arise related to the content integration (such as formatting issues, compatibility problems, or content playback errors, the bidder shall provide on-site and remote troubleshooting support. In collaboration with the content management team, the bidder shall quickly identify, diagnose, and resolve any compatibility issues that may emerge between the content and the AV system. This could involve software patches, firmware updates, or adjustments to content formatting.

<u>Scope of Interiors Works:</u>

- i. <u>Dismantling Works</u>: Dismantling of existing wall cladding, flooring, and brickwork partitioning of reception waiting room as per the requirements outlined in the BoQ/ drawing. This includes the careful removal and disposal of existing materials without causing damage to the underlying structure.
- ii. <u>Plywood Partitions and Paneling:</u> Installation of plywood partitions and paneling with aluminum frameworks. These partitions will serve as the base for the final finishes, providing structural integrity and design flexibility for the internal walls.
- iii. <u>Solid Acrylic Finish:</u> Application of a 12 mm thick solid acrylic finish for exposed surfaces. This includes premium Corian laminate finishes, offering a high-end aesthetic and durability for all visible surfaces.
- iv. <u>Stain Resistant Carpet Flooring:</u> Provision and installation of stain-resistant carpet flooring across all areas.
- v. <u>Acoustical False Ceiling:</u> Installation of a combination of different types of acoustical false ceilings, which will include
 - a. Plain Gypsum Ceiling
 - b. Perforated Ceiling for areas requiring sound absorption.

- vi. Solid Acrylic Finish Ceiling (12mm thick Corian laminate finish) as per the design specifications to achieve the desired acoustic effects and aesthetics.
- vii. <u>Sensor Doors:</u> Supply and installation of sensor-operated doors as per the specifications for both the entrance and exit. These automatic doors will be energy-efficient and offer enhanced accessibility.
- viii. <u>Switchable Glass Partition</u>: Provision and installation of a switchable glass partition between the entrance and display area. This partition should have the functionality to transition between transparent and opaque states, providing privacy and flexibility in space.
 - ix. <u>Diorama and LED Globe Staging:</u> Construction and installation of diorama and LED globe staging works. These features will be designed and fabricated as per the specified design drawings, incorporating LED lighting for enhanced visual appeal and effect.
 - x. <u>Sofa/Furniture for Visitors</u>: Supply and installation of high-quality sofa and furniture for the visitor areas. The furniture will be made to ensure comfort, aesthetic coherence with the overall design, and durability for regular use as per the design and specification.
 - xi. <u>Motorized Vertical Blinds:</u> Provision and installation of motorized vertical blinds for the external glass façade of the building.

Scope of Electrical Works: The electrical work shall have to be carried out by the licensed electrical contractor under the supervision of qualified electrical supervisor. The scope of works for the contractor pertaining to electrical works shall include the following:

- I. <u>Earthing & Safety Equipment</u>
 - i. <u>Installation of Equipment and Systems</u>: The contractor shall install the necessary equipment and systems for grounding the electrical systems within the Experience Center as per the instructions of the Consultant/ NABARD. This includes earth rods, grounding conductors, and connection points to ensure a safe and effective earthing system.
 - ii. <u>Safety and Compliance</u>: The contractor is responsible for ensuring that all earthing systems comply with relevant electrical standards and safety regulations. This includes conducting inspections and tests to verify proper installation and functionality.
- II. <u>MV Distribution Board</u>
 - i. <u>Supply and Installation</u>: The contractor shall supply and install the Medium Voltage (MV) Distribution Board, which is essential for distributing electrical power from the main supply to various circuits within the Experience Center. The MV Distribution Board should be appropriately rated as per the specifications to handle the required load and meet all safety and performance standards.
 - ii. <u>Power Distribution:</u> The contractor shall ensure that electrical power is efficiently distributed to different circuits within the Experience Center, including critical areas such as lighting, power outlets, HVAC systems, and any specialized equipment.

- III. Cables (Power & Circuit Wiring)
 - i. <u>Supply of Cables:</u> The contractor shall supply various types of electrical cables required for power distribution within the Experience Center. This includes selecting cables with appropriate ratings for voltage, current, and environmental conditions as per the specifications.
 - ii. <u>Laying of Cables</u>: The contractor shall lay the electrical cables as per the approved layout and design plans. This includes proper routing, securing, and protection of cables to ensure reliable and safe power distribution throughout the Experience Center.
- IV. Point Wiring
 - i. <u>Provision of Electrical Wiring</u>: The contractor shall provide electrical wiring as per the specifications for various points within the Experience Center. This includes wiring for sockets, switches, and lighting points to ensure adequate electrical connectivity and functionality.
 - ii. <u>Compliance with Standards:</u> The contractor shall ensure that all point wiring is done in compliance with relevant electrical codes and standards. This includes using appropriate wiring methods, materials, and techniques to ensure safety and reliability.
- V. <u>Light Fixtures</u>
 - i. <u>Supply of Lighting Elements:</u> The bidder shall supply various lighting elements selected for their aesthetic appeal and adequate illumination within the Experience Center. This includes fixtures such as downlighters, ripple suspended ring lights and recessed adjustable COB lights.
 - ii. <u>Installation of Light Fixtures</u>: The bidder shall install the lighting elements as per the approved design and layout plans. This includes proper mounting, wiring, and testing of the fixtures to ensure optimal lighting performance and enhance the Experience Center's design.

Scope of AV System: The bidder shall supply and install the Audio-Visual system as per the specifications and as approved by NABARD.

- i. <u>Equipment Procurement and Supply</u>: The bidder shall identify and procure all AV system components, including audio devices, Active LEDs, Diorama, LCD, VR Booth control systems, signal processors, cables, connectors, mounting hardware, and any other necessary equipment as mentioned in the BoQ from authorized and approved Original Equipment Manufacturers (OEMs) Ensure the selection of high-quality, reliable, and compatible products from approved reputable OEMs approved by NABARD that meet the Bank's specifications and expectations.
- ii. <u>Installation, Testing and Commissioning</u>: The bidder on approval of NABARD shall install AV equipment at specified locations as per the drawings and as per consultant/NABARD instructions. This includes handling and mounting audio devices, Active LEDs, control interfaces, and other equipment according to manufacturer specifications and industry

standards. The bidder shall configure and program the AV control systems to ensure seamless integration of all components. Thorough testing shall be conducted to verify proper functioning and optimize performance. The bidder shall perform comprehensive testing of the AV system to verify its performance, functionality, and compliance with the Bank's requirements. Conduct thorough testing and troubleshooting to validate the successful integration of the AV system with all relevant interfaces and systems. Conduct functional testing to ensure proper audio and video signal routing, control system functionality, and overall system operation, as specified by the Bank. Test the system's performance under different scenarios, including audio clarity, video resolution, network stability, and response time, in accordance with the Bank's expectations. Address any identified issues, defects, or non-compliance to ensure the AV system meets the specified standards defined by the Bank.

iii. <u>Documentation and Training</u>: The bidder shall prepare detailed documentation which includes user manuals, operation guides, and maintenance procedures, as required by the Consultant/ NABARD. Get the documentations approved by the consultant before final submission to NABARD. The bidder shall provide comprehensive training sessions for end-users, administrators, and staff deputed by NABARD on operating the AV system effectively and troubleshooting common issues. Ensure that the Bank has the necessary knowledge and resources to manage and maintain the AV system post- implementation.

VII EVALUATION CRITERIA

Bidders who are preliminarily qualified based on the verification of pre-qualification documents provided, shall be further evaluated both in terms of 'Quality' as well as 'Quoted Price' i.e., Quality Cum Cost Based Selection (QCBS) methodology. The weightage for the 'Quality' is 70 % and the weightage for the 'Quoted Price' is 30 %

Evaluation of Technical Bid: The technical evaluation will consist of the following criteria, which will be scored based on the bidder's submission. The marks to be awarded under different sections and the maximum marks that can be awarded for each criterion are listed in column of evaluation criteria in the table below:

The maximum marks to be allocated against various sub-sections under '**Quality Part of Selection Criteria**' of Bid shall be as hereunder:

Those bidders who score a minimum of 60 marks in the technical evaluation process would become eligible to proceed for financial bidding stage i.e., opening of financial bids.

After opening of financial bids, the evaluation under QCBS process shall be as under:

Technical Score of the bidders will be evaluated using the following formula.

Technical Score = (T x 70)/ T (high)

where T stands for actual marks secured by the bidder and T (high) stands for highest marks secured from among the bidders in the technical evaluation Process.

Technical score shall be calculated up to two decimal places.

 ii. <u>Evaluation of Financial Bid</u>: Financial score of the bidders will be evaluated using the following formula. Financial Score = [(L1 x 30)/ (L)]

Where L1 stands for lowest rate quoted from among the bidders and L stands for rate quoted by the bidder.

Financial Score shall be calculated up to two decimal places.

iii. <u>Combined Evaluation of Technical & Financial Bids:</u>

a. The technical and financial scores of each bidder will be added to compute a composite bid score.

Composite bid score = Technical score + Financial Score

- b. The bidder securing the highest composite bid score will be selected for awarding the consultancy work.
- c. In the event of two or more bids having the same highest composite bid score, the bid scoring the highest marks against 'Quality' criteria (Technical Evaluation Marks) will be recommended for executing the project.
- d. In the event of two or more bids having the same highest marks against 'Quality' criteria, then the bidder scoring higher marks in technical presentation (Sr. No.4 in the Technical Evaluation Matrix) will be recommended for executing the project.

VIII TECHNICAL SPECIFICATIONS

I. <u>Demolition Work:</u>

Rate shall include for provision of:

- i. Prior to start of work, the work site shall be clearly earmarked as per the approved drawing and after leaving some allowance from the boundary, the work site shall be cordoned off with temporary plywood partitions up to the ceiling along the boundary to safeguard the bank's property and staff.
- ii. The work site, at present, has got False ceiling, cabins, doors, marble cladded walls, AC ducts, grilles and other installed furniture/ Civil/ Electrical/ HVAC/ CCTV and other items. All these items are to be carefully dismantled without any disturbance to existing users and during non-office hours. Further, Usable dismantled items to be handed over to the NABARD officials (ACT) and these usable items to be reinstated at the designated location as per the instructions of authorised representative of NABARD. Non-usable items to be taken to approved dumping ground from the site as per the instructions of authorised representative of NABARD.
- iii. Shifting of existing scanning machine placed near to the entrance of proposed Experience Center to the other side of reception (south side) in the entrance lobby as per the instructions of the consultant/ NABARD officer in charge.
- iv. Repairing/sealing to the damage portion after removal of fixtures are to be done immediately.
- v. The bidder should visit the site to ascertain for himself the exact nature and scope of work involved and give quote for the entire work required.

II. <u>Masonry Work:</u>

Rate to be deemed inclusive of following work:

- i. Work at all heights, depth and in all situations and to all shapes and profile and all necessary works like staging, ladders, platforms, double staging etc. all are required for proper execution of works.
- ii. Hacking and roughening of concrete or other surfaces coming in contact with masonry for bondage, cutting bricks/blocks, wastage etc.
- iii. Raking out joints to specified depth either for plaster or pointing or finishing the joints flushes as the work proceeds, all as directed.
- iv. Bedding and pointing wall-plaster, lintels, sills etc. in or on walls, bedding and pointing doors, windows and like in cement mortar.
- v. Making openings for pipes, conduits, ducts etc. and closing the same after completion of such works and finishing as directed.
- vi. Providing at exact locations and to exact sizes pre-designated openings.
- vii. Forming chases for edges for concrete floors or other units, for scaling in of waterproofing layers, etc.
- viii. Providing cement concrete blocks (1:2:4) at doorjambs where required to receive expansion bolts/holdfasts etc.

- ix. Building in holdfasts and or inserts, supplied by the engineer.
- x. Keeping the work well wetted for 10 days.
- xi. Bricks/blocks to be wetted before use
- xii. Bailing out, pumping out or otherwise removing all water, which may accumulate from all causes.
- xiii. Sampling and testing of any other material during the course of work as and when directed.

III. <u>Plaster</u>

Work to be deemed inclusive of following work:

- i. Work at all levels, heights and to all situations and profiles.
- ii. Double scaffolding, working platforms etc.
- iii. A coat of gypsum plaster soon after the curing period is over.
- iv. Work in narrow widths and small quantities unless special provision is made to the contrary.
- v. Preparation to the surfaces by raking out joints in brick or by hacking the concrete surface and wetting the surface before plastering wherever required.
- vi. Thickness of plaster exclusive of the thickness of key i.e. grooves and open joints in brickwork, stonework etc.
- vii. Chamfers of any width, internal and external rounded angles and chases and forming sharp and clean edges as shown.
- viii. Curing, protection and cleaning of all surfaces.
- ix. Keeping all plastered surfaces well wetted for at least 7 days.

IV. <u>Carpets:</u>

- i. Installation of carpets to be required including wastage for temporary fillets, side-forms, templates, moulds, straight edges etc.
- ii. Final preparation of the base, sub-grade or sub-floor including minor trimming of the base to remove slight undulations if necessary.
- iii. Cleaning and watering the surfaces immediately before laying the floor.
- iv. Providing bedding layer to correct levels of slopes as called for.
- v. Cutting, rubbing and polishing surfaces and edges where applicable.
- vi. Rounding off corners, edges and junctions of floors with skirting or dado and also cutting recesses where required to accommodate recessed skirting.
- vii. Forming rounded recess in floor where called for.
- viii. Providing grooves where shown on drawings.
- ix. Work in narrow widths, bands, cornices, and strips and to profiles shown at all heights, levels, and locations and in small quantities, unless otherwise mentioned.

- ii. Gypsum plasterboard is to be prepared for plastering by filling the joints with 'board finish' gypsum plaster as described above and pressing into the plaster,

dry reinforcing jute scrim cloth 3 1/2" wide trowelled as flat as possible. When the plaster to the joints has set, thin coat of neat gypsum plaster is to be applied over the whole surface to level up followed immediately by a finish coat to a total thickness of 3/16". The finish coat when almost set is to be trowelled to a smooth surface using as little water as possible applied with a brush. The admixture of lime with gypsum plaster will not be permitted.

 - a. Product Data: Indicate Product description including solid surface sheets, full range of standard colors, fabrication information and compliance with specified performance requirements. Submit Product data with resistance to list of chemicals.
 - b. Shop Drawings: Submit Shop Drawings for work of this Section in accordance with overall working drawings. Indicate plans, sections, dimensions, component sizes, edge details, thermosetting requirements, fabrication details, attachment provisions, sizes of furring, blocking, including concealed blocking and coordination requirements with adjacent work. Show locations and sizes of cutouts and holes and other items installed in solid surface.

SPECIFICATION OF EQUIPMENT/MATERIAL AND INSTALLATION STANDARDS FOR AIR-CONDITIONING WORKS:

 - ii. All access panels shall be so constructed as to be quickly and easily removable. All outside surface shall be finished with powder coating for protection against humid weather. The condenser fans shall be directly driven and designed to achieve low condensing temperatures & operate continuously and silently.
- 2. EVAPORATING UNIT:-(INDOOR UNIT)
 - i. The cooling coils shall be made of copper tubing having extended aluminum fins. The tube shall be mechanically expanded for positive bonding between tube and fins.

IX. Terms and conditions covering the Comprehensive Annual Maintenance

- 1. Defect liability period is 01 year from the date of commissioning of the project and CAMC shall be 05 years from the completion of Defect liability period. In simple words, bidder has to quote the material with 01-year DLP & should quote, 05 years CAMC value in the price bid with support of service resident Engineer for 05 years. The final BID value will be considered on the basis of the total sum of the schedule of quantities. CAMC charges will be paid on a quarterly basis after service (no advance). Payment for service resident engineers shall be paid on a monthly basis. In the case of absenteeism of service resident engineer, payment shall be deducted on a pro-rata basis. CAMC will be comprehensive (all parts + labor) and including all taxes.
- 2. Service Resident Engineer should be available during working hours or beyond working hours, if required, on all working/non-working days, to set up and keep the Experience Center ready for smooth functionality. Alternate service resident engineer should be made available in case of absence of the actual resources. In case, if required, the resource should be available on weekends or national holidays.
- 3. If material supplied to NABARD is from the stocks of the bidder, then they have to produce the letter from OEM that it is their genuine material with date of procurement along with serial number and model description.
- 4. Active LED screens, Projectors, Multi-touch table, VR booth/ Head Mounted Device should be from OEM only. Customization/local fabrication of the Active LED screen & Display Screen is not allowed. System integrator/ contractor has to provide a letter from OEM stating the complete model no. along with serial no. in order to ensure compliance.
- 5. The contractor should have proper and adequate support mechanism in place at Mumbai to provide all necessary support under this project through their own support offices only. The contractor must also have a centralized help desk for logging of all the service complaints. The firm will arrange the spare parts within the stipulated time or will make standby arrangements at its cost.
- 6. Initially work order will be issued only for execution of work. The work order for CAMC & Service Engineer shall be issued subsequently.
- 7. During the Defect Liability Period (DLP), the bidder must provide quarterly site visits to ensure the proper functionality, maintenance, and performance of the installed AV & Allied Systems.
- 8. The annual increase in CAMC amount beyond the 05-year period will be as per Indian Electrical and Electronics Manufacturers Association (IEEMA) formula or mutually decided between NABARD and Bidder.
- 9. The terms and conditions of maintenance of services required after commissioning, i.e. during warranty and CAMC period as specified, will be applicable both during warranty and CAMC. The objective of the quarterly site visits during the Defect Liability Period (DLP) is to ensure the ongoing

functionality, performance, and maintenance of the AV systems installed by the successful bidder. The visits aim to identify and rectify any defects, issues, or deficiencies in the AV systems, ensuring their optimal operation and client satisfaction.

10. Scope of Work for Quarterly Site Visits for 01 Year in Defect Liability Period shall include the following:

i.<u>System Inspection and Testing:</u>

- a. Conduct a thorough inspection of the AV systems, including Active LEDs, VR booth, projectors, multi touch table, audio devices, and control systems.
- b. Perform functional testing to verify that the systems are operating according to the agreed specifications and performance standards.
- c. Identifying any defects, malfunctions, or non-compliance with the tender requirements and document them for rectification.

ii.<u>Defect Rectification:</u>

- a. Address and rectify any defects or malfunctions identified during the inspection.
- b. Ensure that any identified issues are corrected efficiently and timely to ensure optimal performance of the AV systems.
- c. Collaborate with the bidder to resolve any issues and restore the systems to full functionality.

iii.<u>Preventive Maintenance:</u>

- a. Perform preventive maintenance tasks, such as cleaning and maintaining equipment (e.g., Active LEDs, Diorama, projectors, Multi touch table, connectors).
- b. Check and update the firmware/software of the AV systems as necessary, including any required updates or patches.

iv. Documentation and Reporting:

- a. Prepare detailed reports after each site visit, documenting findings, actions taken, and any ongoing issues or recommendations.
- b. Maintain a comprehensive record of site visits, including dates, activities performed, and any materials or spare parts used.
- c. Provide regular status updates to NABARD, highlighting progress on defect rectification, maintenance tasks completed, and the overall health of the AV systems.
- v.<u>Scope of Services:</u> Contractor will provide competent personnel, all the necessary labors, materials, equipment and tools for performing the following duties:
 - a. <u>Provide comprehensive maintenance</u> of contracted services and manage the processes and procedures to ensure reliable, safe and effective operation of the Contracted Services installations supporting the facility.

- b. <u>Period of preventive maintenance</u> monthly to meet on an agreed timetable, at least once a month, with NABARD and prepare and submit monthly service performance reports to demonstrate that the AV system at the Experience Center is working at optimal level.
- c. To regularly review service performance reports and deal with any item that is identified as abnormal, faulty or defective and may result in disruption of Experience Center.
- d. Manage all situations of escalation in a professional manner to satisfactory Conclusion.
- e. Essential spare/materials schedules to be established and stock/condition controls maintained.
- f. Back up support staff to attend site for familiarity.
- g. Replacement resident Engineer to be educated and aware of site requirements well in advance to ensure continuity of service performance.
- h. Coordinate, supervise and carry out all maintenance work.
- i. Ensure that all works are carried out are in accordance with "Best Practice" and safety regulations, respond to alarm paging and emergency calls from NABARD, provide site attendance within the call-out time, and take all the necessary corrective actions to restore the service within the maximum downtime.
- j. Where the repair work has impact or risk of services interruption, escalate immediately to NABARD to schedule appropriate time for carrying out the necessary corrective actions.

X SAFETY CODE

- 1. Appropriate precaution should be taken care of during the work.
- 2. The Contractor shall maintain in a readily accessible place first aid appliances including adequate supply of sterilized dressings and cotton wool.
- 3. An injured person shall be taken to a public hospital without loss of time, in cases where the injury necessitates hospitalization.
- 4. No portable single ladder shall be over 8 meters in length. The width between the side rails shall not be less than 30 cm clear and the distance between two adjacent rungs shall not be more than 30 cm. When a ladder is used an extra mazdoor shall be engaged for holding the ladder.
- 5. Care must be taken while unpacking. Band cutter should be used to cut all steel straps securing the package.
- 6. Every opening in the floor of a building or in a working platform be provided with suitable means to prevent the fall of persons or materials by providing suitable fencing or railing whose minimum height shall be one meter.
- 7. Workers employed on mixing and handling material shall be provided with protective footwear and rubber hand gloves.

- 9. The Employer reserves the right to instruct the Contractors to take additional safety precautions if found necessary.
- 10. All workers shall be provided with helmets, Safety Shoes, Safety belts, Safety Jackets and Safety Equipment for using Jhula.
- 11. All workers shall be provided with kits in order to ensure the COVID-19 appropriate behavior in the premises.

PRE-CONTRACT INTEGRITY PACT

(To be submitted On Rs. 200/- non-judicial stamp paper)

This pre-bid pre-contract Agreement (hereinafter called the Integrity Pact) is made on day of the month of between, NATIONAL BANK FOR AGRICULTURE AND RURAL DEVELOPMENT (NABARD), represented by CGM, NABARD, Head Office, Mumbai Shri _, (hereinafter called the "Employer", which expression shall mean and include, unless the context otherwise requires, his successors in office and assigns) of the First Part and M/s represented bv Shri (hereinafter called "Bidder" which expression shall man and include, unless the context otherwise requires, his successors and permitted assigns) of the Second Part.

WHEREAS the Employer proposes to carry out the work of "_____" and the Bidder is willing to offer/ has offered the quotes and

WHEREAS THE Bidder is a private company/ public company/ Government undertaking/ partnership/ registered export agency, constituted in accordance with the relevant law in the matter and the Employer is a body corporate established under NABARD Act, 1981 having its Head Office at Plot No. C-24, Block 'G', Bandra-Kurla Complex, Bandra (East), Mumbai.

NOW, THEREFORE,

To avoid all forms of corruption by following a system that is fair, transparent, and free from any influence/ prejudiced dealings prior to, during and subsequent to the currency of the contract to be entered into with a view to:

Enabling the Employer to obtain the desired said stores/ equipment at a competitive price in conformity with the defined specifications by avoiding the high cost and the distortionary impact of corruption on public procurement and

Enabling Bidders to abstain from bribing or indulging in any corrupt practice in order to secure the contract by providing assurance to them that their competitors will also abstain from bribing and other corrupt practices and the EMPLOYER will commit to prevent corruption, in any form, by its officials by following transparent procedures.

The parties hereto hereby agree to enter into this Integrity Pact and agree as follows:

Commitments of the Employer

1.1 The Employer undertakes that no official of the Employer, connected directly or indirectly with the contract, will demand, take a promise for or accept, directly or through intermediaries, any bribe, consideration, gift, reward, favour or any material or immaterial benefit of any other advantage form the BIDDER, either for themselves or for any person, organization or third party related to the contract in exchange for an advantage in the bidding process, bid evaluation, contracting or implementation process related to the contract.

1.2 The Employer will, during the pre-contract stage, treat all BIDDERs alike and will provide to all BIDDERs the same information and will not provide any such information to any particular BIDDER, which could afford an advantage to that particular BIDDER in comparison to other BIDDERs.

1.3 All the officials of the EMPLOYER will report to the appropriate Government office any attempted or completed breaches of the above commitments as well as any substantial suspicion of such a breach.

2. In case any such preceding misconduct on the part of such official(s) is reported by the BIDDER to the EMPLOYER with full and verifiable facts and the same is prima facie found to the correct by the EMPLOYER, necessary disciplinary proceedings, or any other action as deemed fit including criminal proceedings may be initiated by the EMPLOYER and such a person shall be debarred from further dealings related to the contract process. In such a case while an enquiry in being conducted by the EMPLOYER the proceedings under the contract would not be stalled.

3. Commitment of BIDDERs

3.1 The BIDDER commits itself to take all measures to prevent corrupt practices, unfair means and illegal activities during any stage of its bid or during a pre-contract or post-contract stage in order to secure the contract or in furtherance to secure it and in particular commit itself to the following: -

3.2 The BIDDER will not offer, directly or through intermediaries, any bribe, gift, consideration, reward, favour, any material immaterial benefit or other advantage, commission, fees, brokerage or inducement to any official of the EMPLOYER, connected directly or indirectly with the bidding process, or to any person, organization or third party related to the contract in exchange for any advantage in the bidding, evaluation, contracting and implementation of the contract.

3.3 The BIDDER further undertakes that it has not given, offered or promised to give, directly or indirectly any bribe, gift, consideration, reward, favour, any material or immaterial benefit or other advantage, commission, fees, brokerage or inducement to any official of the EMPLOYER or otherwise in procuring the Contract or forbearing to do or having done any act in relation to the obtaining or execution of the contract or

any other contract with the Bank for showing or forbearing to show favour or disfavour to any person in relation to the contract or any other contract with the Bank.

3.4 BIDDERs shall disclose the name and address of agents and representatives, and Indian BIDDERs shall disclose their foreign principles or associates.

3.5 BIDDERs shall disclose the payments to be made by them to agents/ brokers or any other intermediary, in connection with this bid/ contract.

3.6 The BIDDER further confirms and declares to the EMPLOYER that the BIDDER is the original manufacturer/ integrator/ authorized government sponsored export entity of the defence stores and has not engaged any individual or firm or company whether Indian or foreign to intercede, facilitate or in any way to recommend to the EMPLOYER or any of its functionaries, whether officially or unofficially to the award of the contract to the BIDDER, nor has any amount been paid, promised or intended to be paid to any such individual, firm or company in respect of any such intercession, facilitation or recommendation.

3.7 The BIDDER, either while presenting the bid or during pre-contract negotiations or before signing the contract, shall disclose any payments he has made, is committed to or intends to make to officials of the EMPLOYER or their family members, agents, brokers or any other intermediaries in connection with the contract and the details of services agreed upon for such payments.

3.8 The BIDDER will not collude with other parties interested in the contract to impair the transparency, fairness, and progress of the bidding process, bid evaluation, contracting and implementation of the contract.

3.9 The BIDDER will not accept any advantage in exchange for any corrupt practice, unfair means and illegal activities.

3.10 The BIDDER shall not use improperly for purposes of competition or personal gain or pass on to others, any information provided by the EMPLOYER as part of the business relationship regarding plans, technical proposals and business details, including information contained in any electronic data carrier. The BIDDER also undertakes to exercise due and adequate care lest any such information is divulged.

3.11 The BIDDER commits to refrain from giving any complaint directly or through any other manner without supporting it with full and verifiable facts.

3.12 The BIDDER shall not instigate or cause to instigate any third person to commit any of the actions mentioned above.

3.13 If the BIDDER or any employee of the BIDDER or any person acting on behalf of the BIDDER either directly or indirectly is a relative of any of the officers of the EMPLOYER, or alternatively if any relative of an officer of the EMPLOYER has financial interest/ stake in the BIDDER's firm, the same shall be disclosed by the BIDDER at the time of filling of tender.

The term 'relative' for this purpose would be as defined in Section 6 of the Companies Act 1986.

3.14 The BIDDER shall not lend to or borrow any money from or enter into any monetary dealings or transactions, directly or indirectly, with any employee of the EMPLOYER.

4. Previous Transgression

4.1 The BIDDER declares that no previous transgression occurred in the last three years immediately before signing of this Integrity Pact, with any other company in any country in respect of any corrupt practices envisaged hereunder or with any Public Sector Enterprises in India or any Government Department in India that could justify BIDDER's exclusion from the tender process.

4.2 The BIDDER agrees that if it makes incorrect statement on this subject, BIDDER can be disqualified from the RFP process or the contract, if already awarded, can be terminated for such reason.

5. Earnest Money Deposit (Security Deposit)

5.1 While submitting commercial bid, the BIDDER shall deposit an amount Rs. ______ as Earnest Money/ Security Deposit, with the EMPLOYER through online in favour of NABARD

5.2 The Earnest Money/ Security Deposit shall be valid up to a period of one year or the complete conclusion of the contractual obligations to the complete satisfaction of both the BIDDER and the EMPLOYER, including defect liability period, whichever is later.

5.3 In case of the successful BIDDER a clause would also be incorporated in the Article retaining to Performance Bond in the Purchase Contract that the provisions of Sanctions for Violation shall be applicable for forfeiture of Performance Bond in case of a decision by the EMPLOYER to forfeit the same without assigning any reason for imposing sanction for violation of this Pact.

5.4 No interest shall be payable by the EMPLOYER to the BIDDER on Earnest Money/ Security Deposit for the period of its currency.

6. Sanctions for Violations

6.1 Any breach of the aforesaid provisions by the BIDDER or anyone employed by it or acting on its behalf (whether with or without the knowledge of the BIDDER)

shall entitle the EMPLOYER to take all or any one of the following actions, wherever required:

- i. To immediately call off the pre-contract negotiations without assigning any reason or giving any compensation to the BIDDER. However, the proceedings with the other BIDDER(s) would continue.
- ii. The Earnest Money Deposit (in pre-contract stage) and/ or Security Deposit/ Performance Bond (after the contract is signed) shall stand forfeited either fully or partially as decided by the EMPLOYER and the EMPLOYER shall not be required to assign any reason thereof.
- iii. To immediately cancel the contract, if already signed, without giving any compensation to the BIDDER.
- iv. To recover all sums already paid by the EMPLOYER, and in case of an Indian BIDDER with interest thereon at 2% higher than the prevailing Prime Lending Rate of State Bank of India, while in case of a BIDDER from a country other than India with interest thereon at 2%, higher than the LIBOR. If any outstanding payment is due to the BIDDER from the EMPLOYER in connection with another contract for any other stores, such outstanding payment could also be utilized to recover the aforesaid sum and interest.
- v. To encash the advance bank guarantee and performance bond/ warranty bond, if furnished by the BIDDER, in order to recover the payments, already made by the EMPLOYER, along with interest.
- vi. To cancel all or any other contracts with BIDDER. The BIDDER shall be liable to pay compensation for any loss or damage to the EMPLOYER resulting from such cancellation/ rescission and the EMPLOYER shall be entitled to deduct the amount so payable from the money(s) due to the BIDDER.
- vii. To debar the BIDDER from participating in future bidding processes of the Government of India for a minimum period of five years, which may be further extended at the discretion of the EMPLOYER.
- viii. To recover all sums paid in violation of this Pact by BIDDER(S) to any middleman or agent or broker with a view to securing the contract.
 - ix. In cases where irrevocable Letters of Credit have been received in respect of any contract signed by the EMPLOYER with the BIDDER, the same shall not be opened.
 - x. Forfeiture of Performance Bond in case of a decision by the EMPLOYER to forfeit the same without assigning any reason for imposing sanction for violation of this Pact.

6.2 The EMPLOYER will be entitled to take all or any of the actions mentioned at para 6.1(i) to (x) of this Pact also on the Commission by the BIDDER or any one employed by it or acting on its behalf (whether with our without the knowledge of the BIDDER), of an offence as defined in Chapter IX of the Indian Penal code, 1860 or Prevention of Corruption Act, 1988 or any other statute enacted for prevention of corruption.

6.3 The decision of the EMPLOYER to the effect that a breach of the provisions of the Pact has been committed by the BIDDER shall be final and conclusive on the BIDDER. However, the BIDDER can approach the Independent Monitor(s) appointed for the purposes of this Pact.

7. Fall Clause

7.1 The BIDDER undertakes that it has not supplied/s not supplying similar product/ systems or subsystems at a price lower than that offered in the present bid in respect of any other Ministry/ Department of the Government of India or PSU and it is found at any stage that similar product/ systems or sub systems was supplied by the BIDDER to any other Ministry/ Department of the Government of India or a PSU at a lower price, then that very price, with due allowance for elapsed time, will be applicable to the present case and the difference in the cost would be refunded by the BIDDER to the EMPLOYER, if the contract has already been concluded.

8. Independent Monitors

8.1 The EMPLOYER has appointed Independent Monitor Shri Jagdeep Kumar Ghai [P&TA, FS (Retd)] (hereinafter referred to as Monitor) for this Pact in consultation with the Central Vigilance Commission.

8.2 The task of the Monitor shall be to review independently and objectively whether and to what extent the parties comply with the obligations under this Pact.

8.3 The Monitor shall not be subject to instructions by the representatives of the parties and perform their functions neutrally and independently.

8.4 Both the parties accept that the Monitors have the right to access all the documents relating to the project/ procurement, including minutes of meetings.

8.5 As soon as the Monitor notices or has reason to believe, a violation of this Pact, he will so inform the Authority designated by the EMPLOYER.

8.6 The BIDDER(s) accepts that the Monitor has the right to access without restriction to all Project documentation of the EMPLOYER including that provided by the BIDDER. The BIDDER will also grant the Monitor, upon his request, and demonstration of a valid interest, unrestricted and unconditional access to his project documentation. The same is applicable to Subcontractors. The Monitor shall be under contractual obligation to treat the information and documents of the BIDDER/ Subcontractor(s) with confidentiality.

8.7 The EMPLOYER will provide to the Monitor sufficient information about all meetings among the parties related to the Project provided such meetings could have an impact on the contractual relations between the parties. The parties will offer to the Monitor the option to participate in such meetings.

8.8 The Monitor will submit a written report to the designated Authority of EMPLOYER within 8 to 10 weeks from the date of reference or intimation to him by the EMPLOYER/ BIDDER and should the occasion arise submit proposals for correcting problematic situations.

9. Facilitation of Investigation

In case of any allegation of violation of any provisions of this Pact or payment of commission, the EMPLOYER or its agencies shall be entitled to examine all the documents including the Books of Accounts of the BIDDER and the BIDDER shall provide necessary information and documents in English and shall extend all possible help for the purpose of such examination.

10. Law and Place of Jurisdiction

This Pact is subject to Indian Law. The place of performance and jurisdiction is the seat of the EMPLOYER.

11. Other Legal Actions

The actions stipulated in this Integrity Pact are without prejudice to any other legal action that may follow in accordance with the provisions of the extant law in force relating to any civil or criminal proceedings.

12. Validity

12.1 The validity of this Integrity Pact shall be from date of its signing and extend up to 5 years or the complete execution of the contract to the satisfaction of both the EMPLOYER and the BIDDER/ Seller, including warranty period, whichever is later in case BIDDER is unsuccessful, this Integrity Pact shall expire after six months from the date of the signing of the contract.

12.2 Should one or several provisions of this Pact turn out to be invalid, the remainder of this Pact shall remain valid. In this case, the parties will strive to come to an agreement to their original intentions.
