11. I / We agree to pay the worker/workers engaged as per the minimum wages declared by the authority under Contract Labor Rules Act 1970 from time to time and agree to pay the same with immediate effect.

12. The rates quoted by me / us are firm and shall not be subjected to variations on account of fluctuation in the market rates, taxes or any other reasons whatsoever during the entire contract period except the difference of minimum wages mentioned at para 10 above and corresponding applicable tax.

Annexure II
TERMS and CONDITIONS

1. Contractors are advised to visit the site and thoroughly understand the nature and scope of the works and be familiar with the site conditions before quoting.
2. The work should be completed within 15 days for receipt of work order.
3. The quantities indicated in the Schedule of Quantities are only tentative and shall be executed only at the sole discretion of NABARD.
4. Quoted rates should be workable and reasonable and should include incidental and all overheads and profits. The contractor should furnish Rate Analysis for scrutiny of the rates by NABARD, if required.
5. Rates should include all relevant Taxes, Duties, Octroi, Levies, Wages as per Act, etc. and should be firm for the entire Contract period. Applicable GST shall be quoted separately in the price bid as per the given format. In case of change in GST rates, the same shall be applied over the quoted rates. No escalation of rates will be allowed for the entire contract period on any another account.
6. Materials used should conform to relevant Indian Standard Codes/International Codes.
7. Specifications and Method of Measurements shall be followed as applicable. However, in the absence of the same and / or in case of any discrepancy, the decision of NABARD will be final.
8. Income Tax as applicable will be deducted from total payment due to the Contractor.
9. The Contractor should have valid License relating to his Contract and the workmen employed by the Contractor should also have the valid License and/or experience in their trade.
10. The Contractor should arrange to obtain necessary insurance cover (Workmen compensation policy) for his employees at his cost and should be responsible for the safety of persons, employed by him.
11. All the Standard Conditions of the Contract shall be binding on the parties as per Indian Contract Act and prevailing Rules.
12. The entire work is required to be completed as specified in the tender.
13. The Contractor shall comply with the provisions of Contract, Labour (Regulation & Abolition) Act, 1970, Minimum Wages Act and all other Labour Laws and other Statutory Regulations (both Central and State) that may be enforced from time to time by the appropriate authorities. NABARD shall not be held responsible for any penalty on failure of the any Labour Regulations. NABARD shall have the power to inspect the Wage Register and for physical verification of salary paid to the staff with reference to any records of the Contractor and to insist the Contractor to comply with Laws.
14. The Contractor should be responsible to fulfill all the obligations in connection with the workers employed by the Contractor for the purpose of the Contract and all the Statutory and other liabilities, if any, including minimum wages, leave salary, uniform, ex-gratia, gratuity, ESI, Provident Fund, Workman Compensation, if any, etc. in connection therewith shall be on the Contractor's account and payable by the Contractor.
15. The Contractor should obtain necessary permission that may be required for the purpose of this Contract from such authorities as may be prescribed by Law from time to time.

24. The work should be carried out with least inconvenience to the Staff of NABARD.
25. The workmen employed by the Contractor should abide by the Rules and Regulations maintained by NABARD in the premises, especially in respect of working hours, entry of the workers to the premises, interpersonal relation with the occupants etc.
26. The Contractor should obtain approvals, if any, necessary for the work from the statutory bodies on behalf of NABARD. However, NABARD may assist the Contractor in respect of any liaison with the Municipal or any other authority for necessary approval / permission with regard to the construction / maintenance works. The fees and other statutory charges, if any, will be reimbursed to the Contractor based on the original receipts produced to NABARD.
27. The Contract can be terminated by NABARD on 5 days' notice if services are found to be unsatisfactory and if there is no improvement even after issue of three notices to the contractor.
28. On-site storage space will be provided to the Contractor subject to availability. NABARD will not be responsible for Contractor's materials. The Contractor may be required to vacate the storage space as per exigency without any extra cost to NABARD.
29. The Contractor shall provide everything necessary for the proper execution of the works. NABARD will not supply any 'T & P' (Tools and Plants) and materials or any other equipment, materials, labour, etc. and no payment in this respect will be made by NABARD. It may be noted that power hammers, breakers or any such equipment's shall not be allowed to use inside the building for any work. The Contractor shall supply and maintain all the scaffoldings, jhulla, T&P (Tools and Plants) etc. at his cost during the execution of any work and remove them as soon as the work is completed.
30. The Contractor shall not directly or indirectly transfer, assign or sublet the Contract or any part of it, without written permission of NABARD.
31. Any defect which may appear within the Defect Liability Period after the completion of work should be rectified by the Contractor at his cost and only thereafter the Security Deposit will be refunded to the Contractor.
32. **Retention Money Deposit (RMD)** will be deducted @ 5% from each on-account bill till the Security Deposit amounts to 5% of the accepted contract value. The Security Deposit (SD) will not bear any interest. The security deposit will be refunded after completion of Defects Liability Period from the date of Completion of works, provided the Contractor has satisfactorily carried out all the rectification works and attended to all defects to the satisfaction of NABARD. If the Tenderer withdraws his Tender before expiry of the validity period of the Tender or if the Contractor fails to execute / complete the works satisfactorily or contractor commits breach of any of the terms and conditions of the contract, NABARD reserves the right to forfeit the EMD / SD. This forfeiture is independent of the liquidated damages provided for the contract. Any Tender not accompanied by the EMD will be rejected.
33. **Defects Liability period:** 03 year from the date of Completion of works certified by NABARD.
34. **Validity of Tender/Quotation Rates:** 3 months from the date of opening of bid/quotation.
35. **Penalty:** 0.25% of the accepted Tender Value per week or part of the week subject to maximum of 5% of the value of work.



36. **Mode of Payment:** All payments will be made through NEFT/RTGS only. The bidding agency must have a bank account and PAN card, the documentary proof of which shall have to be submitted along with the quotation.
37. **PAYMENT:** The contractor shall be entitled to receive payments only after satisfactory completion of work and certification by NABARD Officials. The bills submitted by the contractor will be paid by NABARD after all the statutory deductions viz. RMD @ 5%, TDS @ 2% etc. as applicable.
38. **Dispute Resolution:** In case of any dispute arising out of this contract/award of work between the NABARD and the agency, the decision of the Chief General Manager, NABARD Gujarat Regional Office, will be final and binding on the contractor.
39. All disputes are subject to Ahmedabad jurisdiction only.
