Request for Proposal (RFP) for Empanelment of System Integrators for select States under Centrally Sponsored Project for Computerisation of Primary Agricultural Credit Societies

1. This tender is an extension of the RFP No. NB. HO. IDD/394/Pol-06-PC-7/ 2023-24 dated 21 June 2023 floated by the same name. (Eproc Tender ID: 20734, CPPP Tender ID: 2023_NABAR_716147_1).
2. This separate tender Ref. number is created only for the purpose of modifying the price bid format to include additional locations (States), after 21 June 2023 (presently for Karnataka). All other terms and conditions of the Tender Ref. No. 394 dated 21 June 2023 will be applicable for both the tender IDs.
3. All corrigenda and pre-bid clarifications issued under Tender Ref. No. 394 dated 21 June 2023, will be applicable for both the tender IDs.
4. Since this is an extension of the Tender Ref. No. 394 dated 21 June 2023, the bidders have to submit their bids online for both the tender IDs., viz., Tender Ref. No. 394 dated 21 June 2023 and Tender Ref. No. 448 dated 05 July 2023.
5. If the bidder does not wish to participate in the locations listed out under the Tender Ref. No. 448 dated 05 July 2023, then, the bidder shall submit their price bid as blank or with a suitable comment. However, the commercial bid even if it is 'Nil' has necessarily to be submitted to complete the process.
6. Bidders shall necessarily submit their technical bid under the Tender Ref. No. 394 dated 21 June 2023 only and price bids under both tender IDs.
7. In case the bidder is not interested for submitting a quote for any of the 10 locations (States) mentioned in the price bid format of Tender Ref. No. 394 dated 21 June 2023, but interested to submit for State/s under Tender Ref. No. 448 dated 05 July 2023 then, the bidder shall enter the dummy number "999" in each of the two columns against the row depicting the State of Andaman and Nicobar Islands in price bid of Tender Ref. No. 394 dated 21 June 2023, after which the bidder may mention their quote for their choice of location (State/s, presently Karnataka) in the extended bid of Tender Ref. No. 448 dated 05 July 2023 and complete the tender submission process.
(For example, if a bidder wants to bid only for the State of Karnataka, then, they may mention the dummy number of "999" against Andaman and Nicobar

Islands in Tender Ref. No. 394 and thereafter submit their price bid for
Karnataka in Tender Ref. No. 448 dated 05 July 2023.)

4. Payment shall be on pro-rata basis payable quarterly.
5. Payment under Handholding & Support will be given quarterly basis for the contract period. Calculation of the quarters will be done from the date of Go-Live of PACS.

6. Payment will be made as per the payment terms mentioned in this RFP.
7. Total cost must be quoted in Indian Rupees and in WORDS AND FIGURES.
8. In case of any discrepancy, amount quoted in words will be considered.
9. Prices quoted by the bidder are inclusive of all applicable Taxes i.e. GST (CGST/SGST/IGST). GST will be paid on actual on production of original invoice.
10. Bidder has to show the bifurcation/details of applicable GST (CGST/SGST/IGST) in every invoice. While any increase in the rates of applicable taxes or impact of new taxes imposed by the Central or State Governments of India, subsequent to the submission of commercial Bid shall be borne by State Government, any subsequent decrease in the rates of applicable taxes or impact of new taxes shall be passed on to State Government in its favour. This will remain applicable throughout the Contract Period.
11. The financial by the states shall be based on the above Financial Proposal/ Commercial Bid.
12. No escalation on any account will be payable on the above amounts.
