NABARD invites RFP to ensure that the bidder offering GMP – OPD for eligible pensioners manages it at a high service level and in the most cost-effective manner through in two bid system from the IRDA licensed Non-Life Insurance Companies operating in India for Group Mediclaim Policy – OPD policy offered to eligible pensioners of NABARD.
2. The RFP document is available on NABARD website www.nabard.org and CPPP Portal for download. No physical copy shall be provided by NABARD.
3. NABARD's primary objective in conducting this RFP is to contract with an insurer who:
 - Matches the desired plan, design and contract provisions.
 - Demonstrates the ability to deliver high quality services at a competitive price & claims paying ability at a competitive price.
 - Provides statistics to prove the TAT committed.
4. The interested bidders should refer to the eligibility criteria to confirm if they are eligible to participate in the tender The eligible bidders can upload their bids along with duly signed scanned copies of all relevant documents mentioned in the RFP., in support of their Technical Bid (Section-II) & Financial Bid (Section-IV) on the website of CPPP Portal only within the prescribed time limit. The evaluation of bids will be based on online bids submitted by bidders.
5. It may be noted that NABARD has authorized M/s Aon Risk Insurance Brokers India Pvt. Ltd., to solicit proposals through a two-stage bidding process (comprising Technical Bid and Financial Bid) from IRDA licensed Non - Life Insurance Companies operating in India for Group Mediclaim Policy – OPD programme offered to retired employees of NABARD who are drawn pension. Bidders are advised to submit e-tender (e-bids) through CPPP Portal only, after carefully following the instructions related to systems and procedures as indicated in the CPPP Portal. 

7. A pre-bid meeting will be convened at 11.00 hrs. on 28 August 2025 at NABARD Head Office, BKC Mumbai. Clarifications if any on the bid may be sought from NABARD on or before 17:00 hrs. on 26 August 2025 by email to M/s. Aon Risk Insurance Brokers India Pvt. Ltd. All queries will be clarified during pre-bid meeting and proceedings of the pre-bid meeting will be released through an MOM which will be shared by email.
8. Last date for submission of the RFP is 17:00 hrs. on 06 September 2025. Technical Bid of the RFP will be opened at 11.00 hrs. on 08 September 2025.
9. NABARD reserves the right to reject any or all responses received in response to the RFP without assigning any reason whatsoever. NABARD also reserves the right to cancel the RFP/Tender at any stage, without assigning any reason whatsoever.

Note:

1. In the event of any unforeseen closure of work/ holiday on any of the above days, the same will be opened / held on the next working day.
2. The bidders shall submit their tenders online latest by 17:00 hours on 06 September 2025.
3. Tenders received after due date and time shall be rejected.
4. Tenders not complying with the provisions of bidding documents are liable to be rejected.
5. The selected insurance company has to execute a Service Level Agreement (SLA) and Non-Disclosure Agreement (NDA) on a stamp paper of ₹500/- each respectively with NABARD.
6. M/s. Aon Risk Insurance Brokers India Private Limited shall be our insurance broker for the GMP – OPD policy programme.
