6	Addition of New Clause	Following condition is added after Para 26 of Chapter 5 27. In compliance of instructions contained in Department of Expenditure, Ministry of Finance, GoI OM No. No.F .2AE20 1 4-PPD(PI.) dated 25.06.2016, it is clarified that condition of <b>prior turnover</b> and <b>prior experience</b> with respect to Micro and Small Enterprises and start-ups may be relaxed subject to meeting of quality and technical specifications. The definition of start-ups may be relied upon as defined in the Policy Circular No. 1(2)(1)/2016-MA dated 10.03.2016 issued by Ministry of MSME, GoI which reads as follows “The Startups are normally Micro and Small Enterprises which may not have a track record. These will have technical capability to deliver the goods and services as per prescribed technical& quality specifications, and may not be able to meet the quaiification criterion relating to prior experience and prior turnover”.
