The rates of such tests shall be approved by the Bank on prevailing market rates and expenditure shall be reimbursed on number of tests actually conducted.

3	B(i) of Part-I B of Technical Bidwithin the specified time frame.	Time frame for offering the consultancy services is not indicated in the tender.	Minimum six months or till the structural repair works are executed, whichever is later, from the 7 th day of issue of the work order
4	Price Bid	Scale of fees to be quoted as % of project cost	Project cost is not mentioned in the tender.	The estimated project cost is Rs.50.00 lakh.
