NABARD hereby invites expression of interest from eligible entities for the purpose of empanelment as Recovery Agents. The Recovery Agent will formulate account wise recovery strategy in consultation with the Bank and ensure its execution. For detailed scope of work, eligibility and evaluation criteria and application format please see/refer to the Annexures attached hereto.

2. Interested entities meeting the eligibility criteria may submit the complete application in all aspects, for "empanelment as Recovery Agents, along with required documents in sealed envelopes duly superscribing "Proposal for empanelment of Recovery Agent" to the CGM/OIC of Respective Regional Office of NABARD. The application should be reached by registered/speed post only on or before 10.02.2025 to the respective Regional Office. In case, the applicant desires to submit application for more than one Regional Office, separate application is to be submitted to each RO separately.
